Whereas the undermentioned Acts passed by the Governor of Western Australia, with the advice and consent of the Legis lative Council thereof, were passed in the seventh and eighth years of Her Majesty's

- reign, namely-No. 12 of 7 h Victoria, intituled "An act to regulate summary proceedings be-fore Justices of the Peace."
- No. 13 of 7th Victoria, intituled " An act for adopting certain Acts of Parlia-ment passed in the third and fourth, the fourth and fifth, the fifth and sixth, and the sixth and seventh years of the reign of His late Majesty King Wil-liam the Fourth; as also certain Acts of Parliament passed in the first and second, the second and third, and the fifth and sixth years of the reign of Her present Majesty Queen Victoria respectively, and applying the same in the administration of justice in Wes² tern Australia in like manner as the other laws of England are applied therein."
- No. 15 of 7th Victoria, intituled "An act to prevent the spreading of the infectious disease called the scab in sheep in the
- Colony of Western Australia." No. 2 of 8th Victoria, initialed "An act to enable certain ratepayers in Towns to vote and act as Trustees of such Towns, and to qualify the right of Town. Trustees to vote."
- No. 4 of 8th Victoria, intituled "An act to authorize the Keepers of Boarding Houses to sell spirituous and fermented liquors by retail under special regulations."

Now therefore I, the Governor, do hereby proclaim and make known to all to whom it may concern, that Her Majesty has been gracionsly pleased to confirm and allow the before-mentioned acts.

In consequence of the great increase of late of Dogs in the possession of the Natives, and the frequent injuries which they inflict on the flocks of the colonists, the Governor has been pleased to offer a reward to Constables of One Shilling for the head of each Dog, and of Sixpence for the head of each Puppy, henceforth found in the possession of any of the aboriginal race.

These rewards to be paid on the certi-ficate of a Magistrate, that the head for which the reward is claimed has been dea. stroyed in his presence.

His Excellency requests attention to the fact, that the evil complained of arises almost entirely from the baneful practice of the settlers giving young dogs to the natives.
