His Excellency the Governor has directed the following extract of a Dispatch recently received from the Secretary of State relative to making provision by Law for the Summary conviction and punishment of the Aborigines, to be published for general information:—

By His Excellency's command,

“I concur with you in thinking that provision ought to be made by Law, for the summary conviction and punishment of the Natives, for all offences not of the most serious character. But the propriety of such a change in the Law, will depend on the nature and the sufficiency of the securities which it may be possible to take against the abuse of the power of summary punishment. There is, obviously, great danger of abuse either, from the absence of such a power or from the undue exercise of it. But, on the whole, the greater danger seems to lie on the side of a defect of authority, since it would, probably, generate feuds between the two races, and, with such feuds, all the injuries to property and to life, of which such feuds are generally productive. The better and safer course will, therefore, probably be, to check such animosities in their birth, by creating the jurisdiction which you propose, taking every practicable security against the perversion of it to the purposes of injustice, vexation, or petty tyranny of any kind. The Law which must be framed for the purpose, will, therefore, call for more than the usual circumspection both in framing and executing it.”
