Proclamation.

By His Excellency Lieut.-Col. FREDERICK CHIDLEY IRWIN, Knight Companion of the Royal Hanoverian Guelphic Order, Governor and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies, and Vice Admiral of the same.

In pursuance of the authority in me vested by a certain Act of the Imperial Parliament of Great Britain and Ireland, and passed in the 5th & 6th years of Her Majesty's Reign, intituled "An Act for regulating the sale of Waste Lands belonging to the Crown in the Australian Colonies," I do hereby notify and proclaim, that the following portion of Land in the district of Cockburn Sound, will be offered for sale by Public Auction, by the Collector of Revenue, at Perth, on Wednesday, the 17th day of May, 1848, at the upset price affixed thereto, on the terms and conditions set forth in certain land regulations, dated the 14th June, 1843.

POST OFFICE CHARGES.

LICENSES TO CUT TIMBER.

Much misapprehension appearing to exist respecting the privileges conferred by "Timber Licenses," and by "Sawyers Monthly Licenses." His Excellency the Governor notifies for the information of the public that the timber license for one

year for felling trees on any block of land comprising 640 acres and upwards, confers exclusively the general right of felling and removing timber in the log or otherwise upon such land during the term for which the license may be granted. Whereas, a sawyer's monthly license limits the permission granted to cutting up, or splitting any timber felled for these purposes and carrying away only such split or sawn timber from the waste land of the crown, as one pair of sawyers or splitters may be able to accomplish during the term for which the license may be issued.

Under a sawyers license it is to be understood that not more than three trees are to remain in the log on the ground at one time and no timber can be felled for exportation in the log under its authority.

At the expiration of either of the above description of license all timber remaining on the ground reverts to the crown.

These Regulations do not apply to cutting Sandal-wood for which purpose a separate license is issued in conformity with the regulations published in the Government Gazette of the 8th Oct. 1847.

The charge of the annual license for felling timber for exportation is £20 the square mile of 640 acres one half of which amount must be paid as a deposit on application being made for the license.
