WHEREAS Her Majesty has been graciously pleased by Commission under the Great Seal of the United Kingdom of Great Britain and Ireland, bearing date the 7th day of February, One thousand eight hundred and forty-eight, to constitute and appoint me CHARLES FITZGERALD, ESQUIRE, Commander in the Royal Navy, Governor and Commander-in-Chief in and over the Territory called WESTENN AUSTRALIA, and its Dependencies : NOW I, the Governor and Commander-in-Chief aforesaid, do hereby proclaim and declare that I have this day taken the prescribed Oaths in Executive Council of the said Territory, and that I have assumed the Administration of the said Government accordingly.

WHEREAS the undermentioned Ordinances were enacted by the Governor of Western Australia with the advice and consent of the Legislative Council thereof:

10th Vict., No. 2.—An Ordinance to amend and make perpetual the present laws relative to Auctioneers and Auction Dutres.

- " No. 4.—An Ordinance to make perpetual an Act entitled "An Act to facilitate Actions against persons absent from the Colony and against persons sued as Joint Contractors.
- " No. 5.—An Ordinance to provide further remedies for the annoyance arising from Dogs.
- " No. 6—An Ordinance to provide for the withdrawal of Letters from the Post Office in certain cases.
- " No. 7—An Ordinance to amend the Laws relating to Publican's Licenses.
- "No. 8.—An Ordinance to adopt certain improvements made in the Law of England respecting Libel.
- " No. 9.—An Ordinance to authorise the sale of Wines in smaller quantities than those hitherto appointed by Law.
- " No. 12.—An Ordinance to provide for the establishment of proper places for the burial of the Dead. Now therefore I the Governor do here-
