## Proclamation.

By His Excellency CHARLES FITZGERALD, ESQUIRE, Commander in the Royal Navy, Governor and Commander-in-Chief of the Territory of Western Australia and its Dependencies and Vice-Admiral of the same.

Whereas by the first section of an Ordinance to provide for the establishment of proper places for the burial of the dead, passed the 12th day of August, 1847, it is enacted that it shall be lawful for his Excellency the Governor in Executive Council from time to time, to appoint by Proclamation such place or places in each district as shall be deemed expedient to be reserved for the burial of the dead; Now therefore I the Governor with the advice of the Executive Council, do by this my Proclamation appoint the undermentioned place as a reserve specially set apart for the burial of the dead, of the Roman Ca-

tholic community.

## Proclamation.

By His Excellency CHARLES FITZGERALD, Esquire, Commander in the Royal Navy, Governor and Commander-in-Chief of the Territory of Western Australia and its Dependencies and Vice Admiral of the same.

Whereas the undermentioned Ordinances passed by the Governor of Western Australia with the advice and consent of the Legislative Council thereof were passed in the 10th year of Her Majesty's reign,

10th Vict., No. 13-An Ordinance to provide further remedies against Trespasses by Live Stock, and to promote the construction of fences.

10th Vict., No. 14-An Ordinance for im-

proving the Law of Evidence. 10th Vict., No. 15—An Ordinance to diminish the dangers resulting from Bush fires.

10th Vict., No. 16-An Ordinance to provide a Summary remedy for breach of contracts connected with the Fisheries of the colony.

10th Viet., No. 17-An Ordinance to

amend an Act, intituled "an Act to provide for the Registration of Births Deaths and Marriages in the colony of Western Australia."

10th Vict., No. 19—An Ordinance to repeal the existing Laws respecting the construction and management of Roads, and to establish a Central Board of Works.

10th Vict., No. 1-An Ordinance to renew certain acts appointing places for landing goods within the limits of towns, not being seaport towns.

Now therefore I the Governor do hereby proclaim and make known to all whom it may concern, that Her Majesty has been graciously pleased to confirm and allow the before mentioneff Ordinances.
