PROCLAMATION

By His Excellency CHARLES FITZGERALD, Esquire, Commander of the Royal Navy, Governor and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies, and Vice-Admiral of the same.

IN pursuance of the authority in me vested by a certain Ordinance of the Legislative Council, No. XX of the 4th Victoria, intitled "An Ordinance to establish a Toll to be levied on Sandalwood, to be applied to the construction and repair of public roads and lines of communication," and which provides (section 8) "that it shall be lawful for the Governor, with the advice of the Executive Council, at any time, by proclamation under his hand, to suspend the operation of this Ordinance for such time as he may deem expedient;" I do hereby notify and proclaim the suspension of the operation of the aforesaid Ordinance for a further period of three months from the 1st day of January, 1849.
