WHEREAS by an Act passed in the fifth year of the Reign of His late Majesty King George the Fourth, entitled "An Act for the Transportation of offenders from Great Britain," it was amongst other things enacted, that it should be lawful for His Mejesty, by and with the advice of his Privy Coancil, from time to time to appoint any place or places beyond the seas within or without His Mejesty's Dominions to which Felons and other offenders under sentence or order of Transportation or Rapishment. under sentence or order of Transportation or Banishment should be conveyed.

And whereas in pursuance of the power so vested in the Crown as aforesaid by the said recited Act, certain orders have been made by the advice of the Privy Council during the reigns of their late Majesties King George the Fourth, and King William the Fourth respectively, and of Her present Majesty, for the purpose of appointing places to which such felons and other offenders as aforesaid should be conveyed. be conveyed.

And whereas it is expedient that further and additional provision should be made for the purposes aforesaid.

provision should be made for the purposes aforesaid.

Now therefore, in pursuance and exercise of the powers vested in Her Majesty by the said recited Act, Her Majesty, by and with the advice of Her Privy Council, doth order, and it is hereby ordered, that upon and from the first day of June in this present year, Her Majesty's Settlements in Western Australia shall be places to which felons and other offenders in the United Kingdom there being, or thereafter to be, under sentence or order of Transportation or Banishment, shall be conveved under the Transportation or Banishment, shall be conveyed under the provisions of the said recited Act.

And the Right Honorable Earl Grey, and the Right Honorable Sir George Grey, Bart., two of Her Majesty's Principal Secretaries of State, are to give the necessary directions herein accordingly.

Colonial Post Office, Mauritius, May 1, 1849. SIR,—I avail of this opportunity, vià Adelaide, to apprize you, that the three Mail Boxes from your colony, directed to be forwarded overland, having arrived too late for the Packet, were forwarded on the 25th ultimo, by the Isabella Blyth, bound to London. I beg at the same time to inform you, that all letters and newspapers received at this office for despatch by the Government Mail Packet, are chargeable with alPacket rate, according to weight, as per list annexed.

It will therefore be necessary, on your sending any Mails here to be forwarded overland, that the required Packet postal rates be levied on each letter, &c., and the amount to be remitted with the Mail, either in specie or a bill of Exchange on some respectable house.
