- 8 Spur Piles, 9x9 and 12 feet long. be squared and perfectly straight, and one end pointed
- 180 Sheet Planking, $9x3\frac{1}{2}$, 12 feet long; sawn, and one end pointed
- 20 Pieces of Scantling, 6 inches deep, cut bevel, 3 inches top and 4¹/₂ bottom, and 16 feet long.
- 26 Pieces of 8x4, 9 feet long
- 16 Pieces 8x4, 10 feet long
