Proclamation

By His Excellency CHARLES FITZGERALD, Esquire, Commander in the Royal Navy, Governor and Commander-in-Chief, in and over the Territory of Western Aus-tralia and its Dependencies and Vice-Admiral of the same.

N pursuance of the authority in me vested by a certain Act of the 1mperial Parliament of Great Britain and Ireland, passed in the 5th and 6th years of Her Majesty's reign, intituled, "An Act for regulating the sale of Waste Lands belonging to the crown in the Australian colo-nies." I do hereby notify and proclaim that the following portions of land will be offered for Sale by Public Auction, by the Col-lector or Sub-Collectors of Revenue, at the places and on the days hereinafter mentioned, at one o'clock, at the upset price affixed to each lot respectively, on the terms and conditions set forth in certain Land Regulations dated 14th June, 1843.

- At Perth, on Wednesday, the 2nd July next
- Swan Location No. 126, comprising 15 acres more or less, in the form of a square, extending 12_4^1 chains east, and 12_4^1 chains north from the S.E. corner of Mr Brockman's Swan Location, No.

- Perth Building Lot, N. 4. Upset price £12.
 Perth Suburban Allotment, No. 48, containing 3a. 1r. 20p. Upset Price £4 per acre.
