#### Preemptive Claims.

Colonial Secretary's Office, Perth, February 10, 1852.

The following Regulations for the guidance of parties desirous to purchase lands under lease from the Crown, are published for general information :---

1. No land can be sold while under an 8 years lease from the Crown, except to a lessee claiming to exercise a right of preemption, or to any other person at Public Auction at the end of any omplete year of such eight years lease.

2. Lessees of Pastoral Lands in Class B, or of Tillage Lands, claiming to exercise a right of preemption to purchase at any period of a lease, must send in their applications to the Surveyor General in the usual manner, and in the established printed form of application to purchase Crown Land.

3. All such applications must contain a full and particular description of the land required, and must state the number and extent of the lease within which it is situated.

4. In addition to the application fee of two shillings and sixpence, every application must be accompanied by one third of the amount of the purchase money, calculated at  $\pounds 1$  per acre, or by the receipt for the same of the Sub-Collector of Revenue at Albany, Bunbury, or the Vasse.

5. One calendar month from the date of an application being approved will be allowed for the payment of the balance of purchase money, and title deed fee of forty-five shillings. On failing to make these payments all deposits will be forfeited, and the application will lapse. 6. No smaller quantity than ten acres will be sold out of any land held under Pastoral or Tillage Lease; and no application will be admitted to purchase a portion of either, unless by the recognised holder of such lease, who must at the time be in actual occupation of the same.

7. No person can purchase any part of a Tillage Lease except the lessee thereof.

8. Any other person than the lessee of a Pastoral Lease for 8 years, desirous to purchase a portion of such lease, can do so only at the end of any complete year of the lease, and must send in his aplication as hereinbefore directed, not later than the first day of October in each year.

9. If the application is approved, and the lessee declines to purchase under his preemptive right, the land will be proclaimed for sale in the Government Gazette at least sixty days previous to the intended day of sale, and will be sold under the Regulations contained in the 3rd section of the 4th chapter of the Order in Council, dated 22nd March, 1850; possession being given on the first day of the ensuing January, on completion of the purchase.

10. Lands held under Annual License, whether in class 'A. or class B., will be open to application for purchase at all times in the ordinary form; and if sold, may be entered upon immediately after completion of the purchase.

THE Secretary of State for the Colonies having in a late dispatch re-ceived by His Excellency the Governor, communicated that a gentleman, formerly a resident in this colony, had brought under his notice certain legal views which were adopted with regard to the relation between Master and Servant in Western Australia, and that this question, at the request of the above gentleman, had been submitted for the consideration of the Law Officers of the Crown, His Excellency has directed the following copy of their joint opinion in law on the subject to be published for general information.

Lincons Inn, August 20, 1850. My LORD,-We were honored with your lordship's commands contained in Mr Hawe's 

into contracts with employers, of which the annexed articles of agreement show the ordinary form. The Act 4, Geo. 4th, chap. 34, to enlarge the powers of Justices in determining complaints between masters and servants, and between masters, apprentices, artificers, and others is understood to be in force in the colony

But it appears to be the interpretation put on the act by legal authorities in the colony that if complaint has been made against a servant of one of the classes mentioned in the Act under section 3, and such servant has been punished by committal to the House of Correction, such punishment operates as a discharge of the articles of agreement, and leaves the servant free to engage himself in fresh employment on leaving prison without the consent of his master.

Mr Hawes then stated that he was directed therefore to request that we would furnish your lordship with an opinion on the follow-ing questions. Whether by such punishment the servant

is discharged from the articles of agreement.

Whether if he is not discharged thereby, the term for which he is imprisoned is to be re-ckoned as part of the term for which he is bound to serve under the articles of agreement, or whether the term is to be computed exclusive of the time during which he may have been imprisoned as aforesaid.

Mr Hawes concluded by stating that he was directed also to annex an extract from a report of a Committee of the Legislative Council of Western Australia, shewing the view of the law which is entertained there, and also a case which has been submitted by parties in England to Mr Edge on the same subject with that gentleman's opinion.

In obedience to your lordship's command, we have considered the several documents transmitted to us, and have the honor to report that we are of opinion that by the punishment of imprisonment inflicted under the 4th George 4, chap. 34, the servant is not discharged from the articles of agreement.. We are also of opinion that the time for

which he is imprisoned is to be reckoned as part of the time for which he is bound to serve under the articles of agreement. We have the honor to be, &c.,
