**Proclamation.** By His Excellency CHARLES FITZGERALD, Esquire, Commander in the Royal Navy, Governor and Commander-in-Chief, in and over the Territory of Western Australia and its Dependencies and Vice-Admiral of the same.

N pursuance of the authority in me vested by a certain Act of the Imperial Parliament, passed in the 5th and 6th years of Her Majesty's reign, intituled "An Act for regulating the sale of Wasto Lands belonging to the crown in the Aus-tralian Colonies," I do hereby notify and proclaim that the following portions of land will be offered for Sale by Public Auction, by the Collector and Sub-Collector of Revenue, at the places and on the days hereinafter mentioned, at one o'clock at the upset price affixed to each lot re-apectively, on the terms and conditions set forth in certain Land Regulations, dated June, 1843 :-

Preamble

1. Every Proprietor of Cattle and Horses

to have Brands and to register the same. 2. Justice may one year after passing of Act, authorise owner or lessee of 100 acres to drive in unbranded cattle or horses aged one year in his neighborhood.

Justice may sell impounded cattle and hor-ses after 7 days notice.

At the expiration of 2 years after passing of Act, all cattle &c. not branded with regis-

tered brand to be considered unbranded. 3. Persons driving any stock beyond 20 miles off run or out of herd except their own or unbranded stock, liable to penalty of £10. Any Person not returning stock so driven

off, with all dispatch, liable to a penalty of £10 4. Registered Brands to be published in

Government Gazette.

5. Persons defacing Brands on beasts, finable £10.

Cancelling mark may be used. Register of Brands to be open to inspection 6. Authorised persons driving in unbrandcd cattle may lodge them in Public Pound if within 3 miles, or in private enclosure,

Persons impounding to furnish nearest Justice with list of stock impounded, and also to

post list where stock impounded. 7. Impounded stock to be sold by Justice at noon on seventh day.

Neither person impounding or Justice or-dering sale to purchase any such stock.

8. No Auction duty chargeable on such sale.

9. Act not to extend to persons keeping saddle or draught horses for private use in a stable or enclosure if branded with a registered brand.

10. For protecting persons acting in execution of Act.

 Limitation of proceedings.
 Governor in Executive Council may remit fines.

13. Interpretation clause.

Any persons depasturing 50 head of stock on uninclosed land to keep herdsmen.

A Bill to provide for the establishment of Public Slaughterhouses.

Preamble. 1. The Governor may establish public Slaughter Houses.

2. No unlicensed person to slaughter stock in any townsite, or within 3 miles of the ex-ternal boundary thereof, except in public slaughter houses under a penalty of £10.

The Governor may appoint resident caretak ers of public slaughter houses.
 The Governor in Council may frame

regulations.

Any person infringing regulations liable to a penalty of £20.

6. Any person driving cattle for sale or slaughter in streets between six in the morn-

ing and 12 at night, liable to a penalty. 7. The Governor may limit operation of Ordnance to Townsite.

Special licenses to kill sheep, pigs, and goats within certain limits may be issued.
