Proclamation. By His Excellency CHARLES FITZGERALD, Esquire, Commander in the Royal Navy, Governor and Commander-in-Chief, in and over the Territory of Western Australia and its Dependencies and Vice-Admiral of the same.

N pursuance of the authority in me ves-Parliament, passed in the 5th and 6th years of Her Majesty's reign, initialed "An Act for regulating the sale of Waste Lands belonging to the crown in the Aus-tralian Colonies," I do hereby notify and proclaim that the following portions of land will be offered for Sale by Public Auction, by the Collector and Sub-Collecor of Revenue, at the places and on the days hereinafter mentioned, at one o'clock at the upset price affixed to each lot respectively, on the terms and conditions set forth in certain Land Regulations, dated June, 1843 :-

At Perth, on the 2nd of June next : Swan Location No. 164—Comprising 10 acres Swan Location No. 164—Comprising 10 acres more or less, in form of a square, extending 10 chains SE and 10 chains SW from a spot about 100 chains SE from East corner of T. Downing Street, Dec. 11, 1852. SIR,-I have had under my consideration your Despatch No. 104, of the 30th of July last, accompanied by a Resolution of the Legislative Council on the subject of the intended reduction of the Parliamentary Estimate.

The Resolution sets forth an opinion

that it would be contrary to an implied contract on the part of Her Majesty's Government If they were to withdraw any part of the Colonial Revenues until such time as that Revenue should appear sufficient to meet the whole of the current expenses, and to pay the existing debt to Her Majesty's Government without the imposition of any new Taxes. No reason is assigned for assuming the existence of any such contract, and I am not aware of any foundation for the supposition. When Parliament, in its liberality, thinks proper to grant money out of the taxes raised from the people of this country to defray the local expenses of any of the colonies, it does so from year to year, on the ground that the local resources are not sufficient to meet the current local requirements. It would have been entirely beyond the constitutional power of the Executive Government to give any prospective pledge on the subject. Nor is there the sn.allest ground, either in theory or precedent, for the supposition that Parliament is pledged to grant any fixed amount without abatement, until such time as the colony can defray the whole of its expenses without exception.

With respect to the other ground assigned for refraining from any immediate reduction of the Estimate, I have merely to state that I do not think that any comsideration, founded on such contingencies as that expressed in the minute of the Legislative Council, could warrant Her Majesty's Government in proposing to Parliament to vote more than the amount really required to supply the actual deficiency in the Colonial Revenues.

If the legal effect of the act for establishing Representative Government in the Australian Colonies on this subject be such as they suppose, I do not doubt that whenever the community of the colony may see fit to claim the institutions to which they will become entitled under it, they will at the same time recognize the importance to themselves of making due provision for the permanent maintenance of the more important Civil Services.

New Sonthern Road.

TT is hereby notified for general information, that it is intended forthwith to survey and lay out a line of road between Bunbury and Wonerup near the sea cost, with a view to the same being cleared and opened for use as a public line of communication, pursuant to the provisions of existing Ordinances :---

The new road will be 33 feet wide, and will approach Minnenup farm house in a W. by S. direction from the present Bunbury Busselton road, then wind behind the sea coast through locations 63, 77, 65, 90, 81, 86, 62, 14, 89, C tillage lease 253, and J. Hurford's location 11, crossing Wonnerup Estuary by or near the present ford, and join the present road near McGlashan's on Southern bank of the Ludlow.

Some slight variation from the above arrangement may be found necessary on a more minute examination of the ground.
