## Proclamation.

By His Excellency CHARLES FITZGERALD, Esquire, Commander in the Royal Navy, Governor and Commander-in-Chief, in and over the Territory of Western Australia and its Dependencies and Vice-Admiral of the same.

N pursuance of the authority in me vested by a certain Act of the Imperial Parliament, passed in the 5th and 6th years of Her Majesty's reign, intituled "An Act for regulating the sale of Waste Lands belonging to the crown in the Australian Colonies," I do hereby notify and proclaim that the following portions of land will be offered for Sale by Public Auction, by the Collector and Sub-Collector of Revenue, at the places and on the days hereinafter mentioned, at one o'clock at the upset price affixed to each lot respectively, on the terms and conditions set forth in certain Land Regulations, dated June, 1843 :-

By His Excellency CHARLES FITZGERALD, Esquire, Commander in the Royal Navy, Governor and Commander-in-Chief, in and over the Territory of Western Australia and its Dependencies, and Vice-

WHEREAS the undermentioned Ordinances were passed by me the said Governor, with the advice and consent of the Legislative Council of the said colony, in the Sixteenth year of the reign of Her Majesty Queen Victoria and respectively intitled:-

No 2. An Ordinance for Licensing haw-

kers and peddlers.

No 3. An Ordinance to repeal an Ordinance, passed in the 10th year of the reign of Her present Majesty, No 9 entitled "An Ordinance to authorize the sale of wines in smaller quantities than those hitherto appointed by law," and to make other provisions in lieu thereof.

No 4. An Ordinance to regulate the Brand-

ing of live Stock.

No 5. An Ordinance for the removal of defects in the administration of criminal jusNo 6. An Ordinance for the better prevention of offences.

No 7. An Ordinance to repeal an Act passed in the 6th year of Her present Majesty No 1, intitled "An Act to regulate the slaughtering of Cattle and other stock in Towns" and to enact other provisions in lieu thereof.

No 8. An Ordinance for the improving the

administration of criminal justice.

No 9. An Ordinance to amend the law of evidence.

No 10. An Ordinance to provide for the Establishment of Public Slaughter Houses and to regulate the slaughtering of stock

Now therefore I the Governor, do hereby proclaim and make known unto all whom it may concern that Her Majesty has been gracrously pleased to confirm and allow the before mentioned Ordinances.

Colonial Secretary. Downing Street, May 9th, 1853.

SIR,-At the request of the French Ambassador at this court. I have to acquaint you that a Universal Exhibition for Agricultural and Industrial products will be held at Paris in May 1855, and that every facility will be afforded at the French Custom Houses to the admission of goods belonging to parties residing in the British Colonies, who may be desirous of forwarding articles for exhibition.

I shall have the honor of communicating to you further particulars on this subject so soon as the necessary arrangements shall have been completed by the French Government.

The tenders must be accompanied with a specification giving the scantlings and description, whether of Mahogany or otherwise, and the Piles must not be less than 12 inches dia. (mahogany) in the

smallest part.

For the due performance of the work, onefourth of the amount of contract will be reserved for six months after the entire completion, and the contractor will be required to keep the Bridge in repairduring that time; after which, if the Bridge is found perfect and good, the contractor will then and in that case be paid the balance on his producing an approved certificate.

The last Tender must include the com veyance of all steamers and other ships mails from the Sound.

Parties Tendering are not obliged to tender for the two years but may if they think fit, confine themselves to the year

Tenders must state the rate per mile at which the contractor will undertake to convey additional or express mails; the mode in which it is intended to convey the mail, whether on horseback or in a spring-cart; and the probable time he will take in conveying it to its destination.

The arrivals and departures of mails will be subject to instructions from the General Post Office, and liable to alteration at any time during the year.

Two approved sureties will be required to join the contractor in a bond for the due fulfilment of the duties respectively

contracted to be performed.

No payments will be made on account of any Mail contract until such Bond shall have been respectively signed by the contractor and his sureties; and any breach of contract, in the wilful or negligent departure or delivery of mails at there appointed days and hours will subject the contractor to the loss of a proportionate part of his months pay.

Tenders to be inscribed "Tenders for conveyance of Mails," and each Tender to bear the signatures of the proposed se-

curities.

Parties tendering to attend on the day appointed for the opening of these Ten. ders, when those parties whose Tenders are accepted will be informed of the amount of security, they will respectively be required to give.
