Tenders (in duplicate) will be refceived at this office and opened at noon of that day, for the erection and entire completion

of the said building.

The Government will supply the contractor with the whole of the stone required for the work at Kingsford Mill Jetty, at six shillings (6s) per yard, and no stone will be allowed to be used in any part of the works, except that supplied by the Government.

Persons tendering may include the whole of the work in one tender, or they may tender for masonry and brickwork, carpentry, joinery and ironmongery, ironmongery, plumbing, painting and glazing, separately; or otherwise, for such work or works as belong to their respective trades; but it must be distinctly understood, that any tender for the whole work, will be considered as an whole, and that no portion of it will be accepted together with any other tender, or portion thereof.

Samples for the performance of the masonry can be seen, and such samples will be most rigidly adhered to in the execution of all and every part of the works

Parties whose tenders shall have been accepted will be required, immediately after such acceptance, to furnish the Clerk of works with a true and an attested copy of the bills of quantities of his estitimate, with the prices attached to the various items of which his estimate is made up, respectively.

IS Excellency the Governor directs the publication for general information, of the following Orders in Council. By His Excellency's command,

W. A. SANFORD, Colonial Secretary.

AT the Court at Windsor, the 15th day of April, 1854,

PRESENT, The QUEEN'S most Excellent Majesty in Council.

WHEREAS Her Majesty was graciously pleased, on the twenty-eighth day of March last, to issue Her Royal Declaration in the following terms:
"Her Majesty the Queen of the United

Kingdom of Great Britain and Ireland, hav-Mingdoin of Great Britain and Freiand, having been compelled to take up Arms in support of an Ally, is desirous of rendering the War as little onerous as possible to the Powers with whom she remains at Peace.

"To preserve the commerce of neutrals from all unnecessary obstruction, Her Majesty is willing for the present to waive a part of

is willing, for the present, to waive a part of the belligerent rights appertaining to Her by

the law of nations.

"It is impossible for Her Majesty to forego the exercise of Her Right of seizing articles contraband of war, and of preventing neutrals from bearing the enemy's despatches, and she must maintain the right of a belligerent to prevent neutrals from breaking any effective blockade which may he established with an adequate force against the enemy's forts, harbors, or coasts.

"But Her Majesty will waive the right of seizing enemy's property laden on board a neutral vessel, unless it be contraband of war.

"It is not Her Majesty's intention to claim the confiscation of neutral property, not being contraband of war, found on board enemy's ships; and Her Majesty further declares, that being anxious to lessen as much as possible the evils of war, and to restrict its operations to the regularly organized forces of the country, it is not Her present intention to issue letters of marque for the commissioning

of privateers."

Now it is this day ordered, by and with the advice of Her Privy Council, that all vessels under a neutral or friendly flag, being neutral or friendly property, shall be permitted to import into any port or place in Her Majesty's dominous all goods and merchandize whatsoever, to whomsoever the same may belong; and to export from any port or place in Her Majesty's dominions to any port not blockaded, any cargo or goods, not being contra-band of war, or not requiring a special per-

mission, to whomsoever the same may belong.

And Her Majesty is further pleased, by and with the advice of Her Privy Council, to order, and it is hereby further ordered that, save and except only as aforesaid, all the subjects of Her Majesty and the subjects or citizens of any neutral or friendly State shall and may, during and notwithstanding the present hostilities with Russia, freely trade with all ports and places wheresoever situate, which shall not be in a state of blockade, save and except that no British vessel shall under any circumstances whatsoever, either under or by virtue of this Order, or otherwise, be permitted or empowered to enter or communicate with any port or place which shall belong to or be, in the possession or occupation of Her Majesty's enemies.

And the Right Honorable the Lords Commissioners of Her Majesty's Treasury, the Lords Commissioners of the Admiralty, the Lord Warden of the Cinque Ports, and Her Majesty's Secretary of State for War and the Colonies, are to give the necessary directions herein as to them may respectively appertain.

The QUEEN'S Most Excellent Majesty in Councii.

HER Majesty being compelled to declare war against His Imperial Majesty the Emperor of all the Russias, and being desirous to lesson as much as possible the evils thereof, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, that Russian merchant vessels which, at the time of the publication of this Order, shall be in any ports or places in Her Majesty's Indian territories, under the Government of the East India Company, or within any of Her Majesty's foreign or colo-

nial possessions, shall be allowed thirty days from the time of the publication of this Order in such Indian territories, or foreign or colonial possession, for loading their cargoes and departing from such ports or places; and that such Russian merchant vessels, if met at sea by any of Her Majesty's ships, shall be permitted to continue their voyage if, on examination of their papers, it shall appear that their cargoes were taken on board before the expiration of the above term. Provided that nothing herein contained shall extend, or be taken to extend, to Russian vessels having on board any officer in the military or naval service of the enemy, or any article prohibited or contraband of war, or any despatch of or to the Russian Government.

And it is hereby further ordered by Her Majesty, by and with the advice of Her Privy Council as aforesaid, that any Russian merchant vessel which, prior to the twentyninth day of March now last past, shall have sailed from any foreign port, bound for any port or place in any of Her Majesty's Indian territories, or foreign or colonial possessions, shall be permitted to enter such port or place, and to discharge her cargo, and after-wards forthwith to depart without molestation; and that any such vessel, if met at sea by any of Her Majesty's ships, shall be permitted to continue her voyage to any port

not blockaded.

And the Right Honorable the Lords Commissioners of Her Majesty's Treasury, the Lords Commissioners of the Admiralty, and Her Majesty's Principal Secretary of State for War and the Colonies, the Right Honorable the Commissioners for the Affairs of Tadia and all covernous officers, and an India, and all governors, officers, and authorities, whom it may concern, in Her Majesty's Eost Indian, foreign, and colonial possessions, are to give the necessary directions herein as to them may respectively appertain.

THE Lords of the Council having taken into consideration certain applications for leave to export arms, ammunition, military and naval stores, &c., being articles of which the exportation is prohibited by Her Majesty's proclamation of February eighteenth, one thousand eight hundred and fifty-four; their Lordships are pleased to order, and it is therr Lordsnips are pleased to order, and it is hereby ordered, that permission should be granted by the Lords Commissioners of Her Majesty's Treasury to export the articles so prohibited to be carried coastwise to ports in the United Kingdom, and likewise to all places in North and South America, except the Russian possessions in North America; to the coast of Africa, West of the Straits of Gibraltar, and round the South and East coast of Africa; to the whole cosat of Asia not within the Mediterranean Sea or the Persian Gulf, and not being part of the Russian ter.

ritories; to the whole of Australia, and to all British colonies within the limits aforesaid, upon taking a bond from the persons exporting such prohibited articles that they shall be landed and entered at the port of destination; and that all further permission to export such articles to other parts of the world be only granted upon application te the Lords of the Council at this Board.
