Intended Road Northam to Bolgart.

IS Excellency the Governor has been pleased to direct the publication for the information of all whom it may concern, of the following general description of an intended public road to be run between Northam Townsite and Bolgart Reserve, as nearly as may be found desirable along the line at present in use.

The road to be sixty-six feet wide, com. mencing at the turning off from the present marked road adjoining the new Churchsite at Northam, and extending in a NNW esterly direction crossing the Nor. thern boundary of Northern Townsite about 351 chains from its east end, crossing the Northern boundary of location R about 404 chains from its East end, crossing the Nor. thern boundary of Location @ nearly 36 chains from its east end, entering the Southern boundary of Location W about 851 chains from its West end, crossing the Western boundary of the same Location about 88 chains from the West corner of the Location, and extending thence in a general NNW direction for 111 miles to Bejoording, passing through the Eastern part of Location No 4 From Bejoordnig the Road will pass in a Northerly direction to Bolgart Spring, crossing obliquely through portions of Locations 5 and 37, and thence will take a NN Westerly direc.

SIR,-I transmit to you herewith, a Circular Despatch which the Earl of Clarendon has addressed to Her Malesty's Diplomatic and Consular Servants abroad, instructing them to protect the subjects and the Navy of Sardinia against Russian hostility,

By the Duke of Newcastle's Circular of the 24th of February 1854, you were di-rected to impress on all the Local Authorities under your Government, the duty of affording protection to the Subjects and Commerce of France. It will now be your duty to extend similar protection, assistance, and good offices, to Sardinian Subjects, and especially to the Sardiniau Navy, and to establish with Sardinian Agents, or with the Commanders of Sardinian Ships of War, the same concert in all that effects the interests of the War, as with the Agents and Officers of the Emperor of the French.

You will report to me without delay any measures which you may take in pursuance of the present instruction.

Sardinia, by a Treaty dated 26th ult., has acceded to the Treaty of Alliance concluded on the 10th April, 1854, between Great Britain and France, for the protec-tion of the Ottoman Empire. This Power is thus placed in a state of hostility towards Russia.

As a natural consequence, you will have to extend for the future to Sardinian Sub. jects, and especially to the Sardinian Navy, the assistance and good offices that you were instructed, at the outset of this War, to afford to the subjects of the Queen's August Ally His Majesty the Emperor of

the French; and you will be careful to establish with the Sardinian Agents, or the Commanders of Sardinian Ships of War, the same friendly relations and the some concert in all that affects the interests of the War as with the Agents and Officers of the Emperor of the French.

You will acknowledge the receipt of this despatch.

FIS Excellency the Governor directs the publication of the following Rules recently drawn up by the Commissioners for the affairs of India for the examination of Candidates for the Indian Civil Service.

Examination for Appointments to

the Civil Service of the East India Company.

1.--IN July 1855 an examination will take place, by examiners appointed by the Board of Commissioners for the Affairs of India, of Candidates for appointments to the Civil Service of the East India Company,

2 .- Any natural born subject of Her Majesty who shall be desirous of entering the Civil Service of the Company will be entitled to be examined at such examina-tion, provided he shall, on or before the 1st of May, 1855, have transmitted to the Board of Commissioners :

- (a) A certificate of his age being above eighteen years and under twenty-three years.
- (b) A certificate, signed by a physician or surgeon, of his having no disease, constitutional affection. or bodily infirmity, unfitting him for the Civil Service Company.
- (c) A certificate of good moral character, signed by the head of the school or college at which he has last received his education; or, if he has not received education at any school or college since the year 1852, then such proof (f good moral character as may be satisfactory to the Board of Commissioners.
- (d) A statement of those of the branches dof knowledge hereinafter enumerated, in which he desires to be examined.
- 3.-The examination will take place only in the following branches of knowledge :---

4.—The merit of the persons examined will be estimated by marks, according to the ordinary system in use at several of the Universities, and the numbers set opposite to each branch in the preceding paragraph denote the greatest number of marks that can be obtained in respect of it.

5 .- No candidate will be allowed any marks in respect of any subject of examination unless he shall, in the opinion of the examiners, posses a competent knowledge of that subject.

6.-The examination will be conducted by means of printed questions and written answers, and by vivá voce examination as the examiners may deem necessary.

7-—After the examination shall have been completed, the examiners shall add up the marks obtained by each candidate in respect of each of the subjects in which he shall have been examined, and shall set forth, in order of merit, the names of the twenty candidates who shall have obtained a greater aggregate number of marks than any of the remaining candidates; and such twenty candidates shall be deemed to be selected candidates for the Civil Service of the East India Company. Their choice of the Presidency in India to which they shall be appointed, shall be determined by the order in which they stand on such list.

8.—In August 1856, and August 1857, further examinations of the selected can. didates will take place by examiners ap pointed by the Board of Commissioners for the Affairs of India in the following subjects:—

Law, including the ordinary rules of taking evidence and the mode of conducting civil and criminal 1,000 trials The History of India 400 ... Political Economy Any Language of India in which 400the selected candidate shall have given notice of his desire to be 200 examined ..

and such further examinations will be con. ducted in the same manner as that above described. (The numbers set opposite to each subject donote the greatest number of marks which can be obtained in respect of such subjects.)

9.—Each selected candidate, desirous of being examined at either of the further examinations of 1856 and 1857, shall, two months previously to such examination, transmit to the Board of Commissioners for the Affairs of India a statement mentioning the languages of India in which he is desirous of being examined.

10.—Any selected candidate who, having been examined at the fur:her examination of 1856, shall not have passed, may, nevertheless, be again examined at the further examination of 1857. 11.—Any selected candidate who shall not have passed at one or the other of the further examinations of 1856 and 1857, shall be struck off the list of selected candidates.

12.—The selected candidates who, at either of such further examinations, shall be deemed by the examiners to have a competent knowledge of Law, the History of India, Political Economy, and at least one Language of India, shall be adjudged to have passed and to be entitled to be appointed to the Civil Service of the East India Company; and the names of the set lected candidates who shall have so passed shall be placed in a list in the order of their merit in such examinations, estimated as above by the total number of marks which they shall have obtained in respect of all the subjects in which they shall have been examined at such examination.

13.—The seniority in the Civil Service of the East India Company of the selected candidates shall be determined by the date of the further examination at which they shall be adjudged to have passed; and, as between those who passed at the same further examination, their seniority in such Civil Service shall be determined according to the order in which they stand on the list resulting from such examinan tion.

14.—No person will, even after such examination, be allowed to proceed to India unless he shall comply with the regulations in force at the time for the Civil Service of the East India Company, and shall be of sound bodily health and good moral conduct.
