**Proclamation.**

*By His Excellency CHARLES FITZGERALD, Esq., Commander in the Royal Navy, Governor and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies and Vice Admiral of the same.*

IN pursuance of the authority in me vested by a certain Act of the Imperial Parliament of Great Britain and Ireland, passed in the 5th and 6th years of Her Majesty's Reign, intituled "An Act for regulating the Sale of Waste Lands belonging to the Crown in the Australian Colonies," I do hereby notify and proclaim, that the following portion of Land will be offered for Sale by Public Auction by the Sub-Collector of Revenue, at Albany on the 5th September, 1855, at one o'clock, at the upset price affixed thereto, on the terms and conditions set forth in certain Land Regulations, dated 14th June, 1843 :

*Kojenup Location No. 13.*—Comprising 30 acres more or less bounded on the South by a line 10 chains east and 20 chains west from the centre of Warkelup spring, on the East and West by north line of 10 chains each, and on the North by an east line of 30 chains, all boundaries true, Upset price £1 per acre.

*Kojenup Location No. 14.*—Comprising 10 acres more or less extending 10 chains East and 10 chains South from a spot 2 chains South from NE corner of R. Noorish's Location No. 2, at Warkelup spring, opposite boundaries parallel and equal and all true. Upset price £1 per acre.
