ER Majesty's Government having established a Book Post between the United Kingdom and Western Australia, Notice is hereby given for the information of the public, that from and after this date, Books, Magazines, Reviews, and Pamphlets, (whether printed, written or plain, or any mixture of the three), may be transmitted by the post from this Colony to the United Kingdom, and vice versa, either by Packet viâ Melbourne, or by private Ship direct, at the following reduced rate of postage, viz.:---

For each packet, not exceeding half-apound in weight, six (6d) pence.

For each packet, exceeding half-a-pound and not exceeding one pound, one (1s) shilling.

For each packet, exceeding one pound and not exceeding two pounds, two (2s) shillings, and so on increasing one shilling for every pound, or fraction of a pound.

Provided however that the following Regulations be carefully observed.

1. Every such packet must be either without a cover, or with a cover open at the ends or sides.

2. It must not contain any letter, open or sealed, nor any sealed enclosure whatever.

3. It must not exceed two feet in length, breadth, or width.

4. The postage must be paid in advance by means of stamps.

It must have no writing upon the cover in the nature of a letter, but only the name and address of the person to whom it may be sent.

All legitimate binding, mounting, or covering of the same, or of any portion thereof, will be allowed, whether such binding, &c., be loose or attached, as also rollers in the case of prints; markers, (whether of paper or otherwise), in the case of Books, and, in short, whatever is necessary for the safe transmission of literary or artistic matter or usually appertains thereto.

The packet will be delivered in the United Kingdom without any further charge.
