N pursuance of the authority in me vested by a certain Act of the Imperial Parliament of Great Britain and Ireland, passed in the 5th and 6th years of Her Majesty's Reign, intituled "An Act for regulating the sale of Waste Lands belonging to the Crown in the Australian Colonies," I do hereby notify and proclaim, that the following portion of Land will be offered for sale by public auction, by the Collector of Revenue at Perth, on Wedne day, the 1st day of July, 1857, at one o'clock, at the upset price affixed thereto, on the terms and conditions set forth in certain Land Regulations, dated 14th June, 1843:-

York Town Lot No. 94.—Comprising two (2) acres more or less. Upset price L.250.
On this lot of land which comprises two building allotments, is erected a substantial dwelling house with good farm buildings, including barn, stables, piggery, &c., good garden ground fenced in and a plentiful supply of water at all seasons of the year; this property if well known as the Home-stead of the Gerald Farm at York.

Some land in the immediate neighbourhood of these buildings, formerly comprising the Gerald Farm will shortly be laid out for purchase in sub-

urban Lots.

HEREAS by clause 9 of the 4th chapter of a certain order in Council by Her Majesty Queen Victoria, bearing date the 22nd day of March, IS50, and promulgated in this Colony on the 9th September, 1851, it is made "competent for the Governor of the said colony with the advice of his Executive Council at any time within three months after the determination of any Pastoral Lease and notwithstanding any right of renewal thereof to declare by Proclamation in the Government Gazette, that all or any of the lands comprised in such lease which may be within one mile of any lands which have been granted in fee by the Crown shall thereafter be deemed to be within class A, and whereas certain Pastoral Leases hereunder mentioned have recently ceased and determined, I do hereby notify and proclaim, with the advice aforesaid, that the following portions of the said leases will henceforth be deemed to be within class A and will be subject to all the rules and regulations applicable thereto:—namely, all those lands comprised within the distance of one mile or 80 chains, from the fee simple locations specified opposite to each of the following leases respectively— Out of lease 601, 3000 acres around lo-
