PROCLAMATION.

Y HIS EXCELLENCY Arthur Edward Kennedy Esquire, Governor, and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies and Vice Admiral of the same.

HEREAS the undermentioned ordinances were passed by His Excelency Arthur Edward Kennedy, Esquire, Governor of the said Colony, with the advice and consent of the Legislative Council thereof in the 21st year of the reign of Her Majesty, Queen Victoria, and intituled;

- No. 1. An Ordinance to make additional provisions for Convict Discipline in Western Australia.
- No. 2. An Ordinance for securing a pension to William Henry Mackie, Esquire.
- No. 3. An Ordinance to provide additional Regulations for the Port of Fremantle.
- No. 4. An Ordinance for narrowing Essex street in the Town of Fremantle, and for extending the limits of certain building lots in that Town.
- No. 5. An Ordinance to render more effectual an Ordinance No. 15, 1844, called "An Act to prevent the spreading "of the Infectious Disease called the "scab in sheep in the Colony of Western Australia."
- No. 6. An Ordinance to amend the "Public House Ordinance" 1856
- No. 8. An Ordinance to give legal operation to Land Grants made to deceased persons.

Now therefore, I, the said Arthur Edward Kennedy, do hereby proclaim and make known unto all whom it may concern, that Her Majesty has been graciously pleased to confirm and allow the before mentioned Ordinances.

EFERRING to my Circular Despatch of the 11th August, on the subject of the establishment of a Book Post, between India, and the Colony under your Government.-I transmit herewith for your information, and guidance, copy of a further communication which has been received from the General Post Office, stating that his Grace, the Postmaster-General has obtained the sanction of the Lords Commissioners of the Treasury, for the establishment of a Book Post—between the Australian Colonies and Ceylon, and Mauritius; and that the measure will take effect, from the 1st October next.

SIR.

N continuation of my letter of the 1st. ultimo. I am directed by the Postmaster-General to acquaint you, for the information of Mr. Secretary Labouchere, that His Grace has further obtained the sanction of the Lords of the Treasury for the establishment of a Book Post, between the Australian Colonies and Ceylon, and Mauritius; and that the 1st of October next, has been fixed as the date, for bringing the measure into operation.

The postage to be charged upon books, sent by the Post between the above-mentioned Colonies, will be as follows :-

For a packet not exceeding) 4oz. in weight..... Ditto, above 4oz., and not exceeding $\frac{1}{2}$ lb., Ditto 1lb., o, , , 1lb. Ditto $1\frac{1}{2}$ lb., Ditto 1lb., o, , , 1lb. Ditto 2lbs., 0 6 Ditto, 1 0 Ditto, 6 Ditto, And so increasing sixpence for each additional half-pound, or fraction of $\frac{1}{2}$ pound.

With regard to the mode of accounting for the Postage, I am desired by his Grace to state, that according to the terms of the agreement under which the Mail Packet Service, between this Country and Australia has been established, the entire postage upon all Letters, Newspapers, and Books, despatched from Australia, is to be collected in advance, and retained by the Colonial Post Office.

No share of the Postage, collected upon Book Packets, sent from Australia to Ceylon, and Mauratius; will, therefore, be accounted for to the Post Offices, of the latter Colonies.

To meet this difficulty, the Postmaster-General is of opinion that, as it may be fairly assumed, that the number of books, sent in each direction, between Australia, and Ceylon,-and between Australia, and Mauritius, will be about equal, an arrangement should be made, that the Offices of Ceylon, and Mauritius, instead of accounting to this Office, upon Book Packets, sent to Australia, for two thirds of the postage, and retaining the remaining one-third, shall account to this Office, upon such Book Packets, for one-third of the Postage only—and retain the remaining two-thirds for their share respectively, thus obtaining double the Colonial share of Postage in one direction only, and no postage in the other direction.

In acquainting you with the course intended to be pursued, the Postmaster-General, desires me to request, that you will move Mr. Secretary Labouchere, to cause the Officers administering the Governments of Victoria, New South Wales, South Australia, Western Australia, New Zealand, Tasmania, Mauritius, and Ceylon; to be informed of the arrangements which will be carried out on the date above-mentioned.

VITH a view to accelerating the delivery of correspondence despatched from this Colony to the United Kingdom, via Suez by the Contract Packets, it has been determined by Her Majesty's Postmaster General to open the mails on board the Steamers by which they are conveyed from Alexandria to Malta, and to effect a partial or complete sorting of the Letters and Newspapers, as may be found practicable. meet however any objection that has been raised to the plan of sorting on board, on the ground of the opportunity it would afford for tampering with Letters, it is intended by the regulations that all Registered Letters shall be sent in a separate mail, and that that mail shall not be opened until it arrives in London. Persons wishing their Letters not to be overhauled on board the Packets are requested to have them Registered.

NOTICE TO MARINERS.

LIGHTHOUSES AT KING GEORGE'S SOUND, WESTERN AUSTRALIA.

NOR the guidance of Shipping frequenting King George's Sound, a lighthouse has been erected on the summit of Breaksea Island at the entrance of the Sound, and another at the entrance to Princess Royal Harbour.

A light is exhibited in both between sunset and sunrise.

That on Breaksea Island is a good Catadioptric light of the 2nd order, white, fixed, and elevated 383 feet above sea level. It may consequently be seen in clear weather at the distance of 9 leagues, from an elevation of 12 feet above the

The octagonal iron tower which carries this light is erected near the centre of the island, which is $1\frac{3}{4}$ miles in length E. by S. and W. by N., with an average width of nearly a quarter of a mile. From Breaksea light the extremity of Bald Head bears South 40 degrees West 3 miles, Cape Vancouver at the foot of Mount Gardner East 15 degrees North 7 miles, and the light at the entrance of Princess Royal Harbour West 20 degrees North 61 miles. By a vessel from the Westward the light may first be seen round the steep slope of Bald Head on the bearing of N. E. 1/4 E., just open to the South of the Eclipse Islands. These bearings are magnetic. The light at Princess Royal Harbour is on Point King, the North point of its narrow entrance. It is a fixed white light of the same description as that on Breaksea, but smaller, and is elevated 37 feet above high water. From the mid channel between Breaksea and Michaelmas Islands this light bears W. by N. ½ N., and from the N.E. extremity of Bald Head N. W. ¼ W. It is carried by a wooden square tower 17 feet in height, and 37 feet from the water's edge. All bearings magnetic.
