PROCLAMATION.

*By His Excellency Arthur Edward Kennedy,
Esquire, Governor and Commander-
in-Chief in and over the Territory
of Western Australia and its De-
pendencies, and Vice-Admiral of the
same.*

WHEREAS by Clause 9 of the 4th Chapter of a certain Order in Council by Her Majesty Queen Victoria, bearing date the 22d day of March, 1850, and promulgated in this Colony on the 9th September, 1851, it is made "competent for the Governor of the said Colony with the advice of his Executive Council at any time within three months after the determination of any Pastoral Lease, and notwithstanding any right of renewal thereof, to declare by Proclamation in the *Government Gazette*, that all or any of the lands comprised in such lease which may be within one mile of any lands which have been granted in fee by the Crown shall hereafter be deemed to be within Class A," AND whereas certain Pastoral Leases hereinunder mentioned have recently ceased and determined I do hereby notify and proclaim, with the advice aforesaid, that the following portions of the said leases, will henceforth be deemed to be within Class A, and will be subject to all the rules and regulations applicable thereto: namely,

1350 acres *Avon District*, extending one mile from location 177 within forfeited lease 25.

4420 acres *Victoria District*, extending one mile from locations 28 and 42 within forfeited lease 872.

1300 acres *Sussex District*, extending one mile from locations 85 and 103 within forfeited lease 333.

800 acres *Swan District*, extending one mile from location 181 within forfeited lease 789.
