PROCLAMATION.

By His Excellency Arthur Edward Kennedy Esquire, Governor and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies, and Vice-Admiral of the same.

HEREAS the undermentioned Ordinance was passed by His Excellency Arthur Edward Kennedy, Esquire, Governor of the said Colony, with the advice and consent of the Legislative Council thereof, in the 21st year of the reign of Her Majesty Queen Victoria, and intituled:

No. 9 "An Ordinance for the further Appropriation of the Revenue for the year 1856, and for the General Appropriation of the Revenue for the year 1858."

make known unto all whom it may concern, that Her Majesty has been graciously pleased to confirm and allow the before mentioned Ordinance

PROCLAMATION.

By His Excellency Arthur Edward Kennedy, Esquire, Governor and Commanderin-Chief in and over the Territory of Western Australia and its Dependencies, and Vice-Admiral of the same.

HEREAS by Clause 9 of the 4th Chapter of a certain Order in Council by Her Majesty Queen Victoria, bearing date the 22d day of March, 1850, and promulgated in this Colony on the 9th September, 1851, it is made "competition." tent for the Governor of the said Colony with the advice of his Executive Council at any time within three months after the determination of any Pastoral Lease, and notwithstanding any right of renewal thereof, to declare by Proclamation in the Government Gazette, that all or any of the lands comprised in such lease which may be within one mile of any lands which have been granted in fee by the Crown shall hereafter be deemed to be within Class A," AND whereas certain Pastoral Leases hereinunder mentioned have recently ceased and determined I do hereby notify and proclaim, with the advice aforesaid, that the following portions of the said leases, will henceforth be deemed to be within Class A, and will be subject to all the rules and regulations applicable thereto: namely,

A BILL to extend and enlarge the provisions of "An Ordinance for the Regulation of Gaols, Prisons, and Houses of Correction in the Colony of Western Australia, and for other purposes relating thereto."
