THE following Rules and Orders for the Regulation of Proceedings in Appeals to His Excellency the Governor of Western Australia in Executive Council made and prescribed on the 15th of November, 1853, and on the 4th of April, 1859, respectively, with the advice of the Executive Council are hereby published for general information.

This notice supercedes that of 16th April, 1859, in the Government Gazette of 26th April, 1859, which was erroneously printed.

### RULES AND ORDERS

FOR REGULATING PROCEEDINGS IN APPEALS TO HIS EXCELLENCY THE GOVERNOR IN EXECUTIVE COUNCIL.

- 1.—The party intending to appeal to give 14 days' notice in writing of such his intention to the adverse party.
- 2.—The party intending to appeal shall give security to the satisfaction of His Honor the Commissioner of the Civil Court for the due prosecution of the Appeal, the due performance of such Order or Judgment as the Court of Appeal shall think fit to make, and for the payment of the costs of Appeal.
- 3.—Petitions of Appeal must be lodged with the Clerk of the Council within 28 days after the Decree, Order, Judgment, or sentence of the Civil Court shall have been pronounced; and such Petitions shall state that the requisitions of the foregoing Rules have been complied with.
- 4.—The Clerk of the Council shall lay such Petitions before His Excellency the Governor in Executive Council for consideration, and notify to the Appellant the decision thereon.
- 5.—The Appellant, on receiving a notification that the Appeal will be permitted, shall take out from the Registrar of the Civil Court a copy or transcript of the several proceedings in the suit, including the Pleadings, Evidence, Decree, Order, Judgment or Sentence therein, and such copy shall be certified under the Hand of His Honor the Commissioner of the Civil Court as containing a correct statement of all the proceedings.
- 6.—Such Copy or transcript shall, thereupon be printed by the Appellant, and 10 printed copies thereof shall be delivered by him to the Clerk of the Council, together with the certified copy or transcript.
- 7.—The Appellant shall deliver to the Respondent 4 of such printed copies, at least, 7 days before the Appeal shall be heard.
- 8.—The foregoing Rules having been complied with, the Appellant shall apply to the Clerk of the Council to have the cause set down for hearing, and shall give the Respondent at least 4 clear days' notice of the cause having been set down for hearing, before the same shall be heard.

- 9.—After the cause has been set down for hearing, the hearing thereof may, at the discretion of the Court of Appeal, be postponed or adjourned, on application of either party, on terms.
- 111.—Should the Respondent, having received due notice as aforesaid, omit to appear in person or by counsel at the time appointed for the hearing, the Appeal will be heard ex parte.
- 11.—Should the Appellant neglect to prosecute the Appeal with due diligence, the Respondent should be at liberty to move to have the same dismissed, having first given the appellant, either by service upon him or his solicitor, or by publication in the Government Gazette, one month's notice of motion.
- 12.—No evidence shall be received on the hearing of any appeal, which was not received on the original hearing of the case in the Civil Court.
- 13.—It shall be requisite only to produce, on the hearing of any appeal, the certified copy or transcript referred to in the foregoing rule No. 5. tygether with any original documents produced and given in evidence on the hearing in the Civil Court, and not fully set forth in such certified copy or transcript.
- 14.—The Clerk of the Council shall keep a book, to be called "the Record Book of the Proceedings of the Executive Council as a Court of Appeal," in which accurate minutes of the proceedings, in each case of appeal, shall be entered, and signed, at convenient intervals, by the Governor, as President of the Court.
- 15.—All proceedings in appeals not provided for by the foregoing Rules, to be regulated, so far as may be practicable, in accordance with the practice in appeals to Her Majesty in Council.
