CONVEYANCE OF MAILS.

Colonial Secretary's Office, Perth, September 13th, 1859.

"Tenders for Conveyance of Mails," will be received at this Office up to noon on Friday the 25th November next, for the conveyance of the following Mails from the 1st January to the 31st December, 1860.

A tender may embrace the whole or any portion of the undermentioned lines.

Between Fremantle and the half-way tree on the Perth road, twice daily.

Between Perth and the half-way tree on the Fremantle road, twice daily.

Guildford and Perth, once daily.

Guildford and Northam, once a week.

Northam and York, once a week.

Northam and Toodyay, once a week.

Guildford and Upper Swan, once a week.

Perth and Vasse, viâ Canning, Serpentine, Pinjarrah, Australind, and Bunbury, once a week.

Gingin and Victoria Plains, once a month.

Perth and Albany, once a month; to be conveyed in a spring cart, subject to the following terms.

The Contractor must convey a monthly mail between Perth and Albany, and all foreign mails between the two places on such day in each month as may be fixed by the Post Master General.

He must also convey to Perth by express at any time during the month (on being called upon to do so by the Post Master, King George's Sound,) that is to say before or after the departure of the regular monthly mail for Perth, any English mails whatsoever that may be landed by the Contract Packets at Albany either on their outward or homeward route.

The journey from Perth to Albany, and vice versa, to be accomplished in seven clear days from the time of leaving the Post Office of either place.

The mails each trip not to exceed 800lbs if above that weight the contractor to be paid at the rate of 4d. per lb. over and above that amount

The arrival and departure of mails will be subject to instructions from the Post Master General, and liable to alteration at any time during the year.

Two approved sureties will be required to join the contractors in a guarantee for the due fulfilment of the duties respectively contracted to be performed.

No payment will be made on account of any mail contract until the bond shall have been respectively signed by the contractor and his sureties, and any breach of contract in the wilful or negligent departure or delivery of the mails at the appointed days and hours will subject the contractor to the loss of a proportionate part of his monthly pay, or the cancellation of his contract

The contractors are to convey and deliver all mails which may be entrusted to them under the authority of the Post Master General or any of the Post Masters and to provide secure and water tight lockers for mails in carts, and coverings for the bags on horseback; the contractors moreover will be bound not to convey themselves or permit their servants to convey any letter or packet to the prejudice of the Post Office Revenue under a penalty of Three Pounds for each offence which penalty will be deducted from their monthly pay.

The whole of the mails (excepting those for Albany) may be conveyed either in spring carts or on horseback at the option of the contractor.

The persons employed by any of the contractors to convey mails are to be subject to the approval of the Post Master General both as to age and character.

Further particulars may be obtained on reference to the Post Master General at whose office forms of tender may be had as well as from the Resident Magistrates.

For "The light will be visible from E.N.E seavard, round southerly to S.S.W.," read "The light will be visible to seaward from N.N.E. round southerly to W.S.W."

Wilson's Promontory Light.

WITH reference to the notice published in the Government Gazette on 31st May, 1859, relative to "Coast and Harbor Lights" in Victoria, the following intimation, giving details of the position of, and other matters relating to, the lighthouse on Wilson's Promontory, is published for the general information of mariners.*

NOTICE TO MARINERS.-WILSON'S PROMONTORY LIGHT.

In reference to a note appended to a notice to mariners respecting the abovenamed light, dated the 28th of May, 1859: Notice is hereby given that the light on Wilson's Promontory will be exhibited, as formerly stated, on the evening of the 15th July next, and on every night thereafter, from sunset to sunrise.

The Wilson's Promontory Lighthouse is situated on the south-eastern part of that headland; its approximate position is latitude 39° 9' S., longitude 146° 23' E.

The light will be a catoptric, first class fixed white light, elevated three hundred and forty two (342) feet above the mean level of the sea, and will be seen in clear weather at distance of about twenty-four (24) nautic miles, allowing ten feet for the height of the eye, and at lesser distances according to the state of the atmosphere.

The lighthouse tower is circular, built of stone, and painted white.

The light will be visible to seaward from N.N.E. round southerly to W.S.W., excepting that by the intervention of the adjacent islands the light will be eclipsed to vessels upon the undermen-tioned bearings from it, and for a few degrees on either side of them.

Bearings of islands taken from the lighthouse, and their approximate distances :-

South part of Cleft Island. S. W. by W. $\frac{1}{2}$ W. $\frac{5}{4}$ m. Centre of Rodondo Island. S. $\frac{1}{3}$ W. $\frac{5}{4}$ m. $\frac{1}{64}$ m. $\frac{1}{4}$ m. West Moncur I. S.E. $\frac{1}{4}$ S. $\frac{1}{4}$ m. West Moncur I. S.E. $\frac{1}{4}$ E. 8 m. Cliffy or South Seal I. N.E. $\frac{1}{4}$ N. 17 m. North Seal Island. N.E. by N. $\frac{1}{4}$ m. Cape Wellington . N.E. by N. $\frac{2}{4}$ M. $\frac{1}{4}$ m.

Vessels steering through Bass's Straits, or from Port Phillip, bound eastward round Wilson's Promontory, may first see the light through the gap between Cleft and the adjacent Glennic Island, bearing E.N.E.; as they proceed to the southward and eastward it will be eclipsed for a few degrees by Cleft Island. few degrees by Cleft Island.

When the light bears N.E. the channel between Cleft Island and the Rodondo will be open, and vessels may steer direct for the promontory.

Vessels to the eastward of the Seal Islands and bound round the promontory, sighting the light bearing to the southward of S.W., will be to the northward of the fairway, and should haul out until the light bears S.W. by W, which bearing will lead them clear of Cliffy and the other Seal Islands.

All bearings are by compass.

GELLIBRAND'S POINT LIGHTSHIP.

WITH reference to the notice of 28th June, published in the Government Guzette, page 1379 ante, intimating the establishment of a Lightship off Gellibrand's Point in lieu of the Lighthouse thereon, the attention of masters and persons in charge of vessels entering Hobson's Bay is directed to the notice hereunto attached.

LIGHTSHIP OFF GELLIBRAND'S POINT PORT PHILLIP BAY.

In accordance with a notice issued from this office, dated the 16th of June, 1859, the red light ceased to be exhibited from the tower at Gellibrand's Point last night, and, in lieu thereof, two fixed white lights of equal height, 24 feet apart. were shown from a temporary Lightship moored in four and a half fathoms at low water, off Gellibrand's Point, near the position hitherto occupied by the Black Buoy.

The Lightship has one mast surmounted with a ball. Hull and ball are painted red.

The following bearings were taken from the Lightship :-

Point Cook, S.W. 3 W., 8 miles.

Old Lighthouse, N. by W. ½ W., 550 fathoms. Sandridge Sugar Works, N.N.E., 2 miles 150 fathoms.

White buoy, off St. Kilda bank, N.E. by N., 1 mile 200 fathoms.

This lightship will be replaced on or about the first day of January next by a new vessel, which will exhibit a white revolving light. Full particulars will hereafter be given.

The bearings are by compass.
