INTENDED ROAD FROM PRIOR'S PADDOCK,  
TO NEW BRIDGE OVER THE PRESTON,  
AT LAWRENCE'S FORD.

IT is hereby notified for general information that it is the intention of the Government, as soon as means may be available, to lay out and declare a line of Public road, one chain wide from the South West corner of Prior's Paddock, as nearly as may be found desirable along a line as marked by blazed trees, through Wellington Locations No. 26, 29 and 30, to the New Bridge over the Preston River, at a place known as Lawrence's Ford.

Full particulars of this line will be published in a future notice after the road shall have been laid out and surveyed, and the public are in the meantime cautioned against fencing across or otherwise obstructing the track at present marked.

### PROCLAMATION.

*By His Excellency Arthur Edward Kennedy, Esquire Governor and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies, and Vice-Admiral of the same.*

WHEREAS by a Deed Poll of Grant bearing date the third day of September, One Thousand, Eight Hundred and Forty Four, under the Hand of the Governor and the Public Seal of the said Colony, the Leschenault Location, No. 1, containing one hundred and three thousand acres, was granted unto William Hutt, Edmund William Jerningham, Henry Buckle, John Chapman, Charles Enderby, and James Irving. And whereas by the said Deed Poll power was reserved to the Crown to resume and enter upon possession of any part of the said Land which it might at any time by the Crown be deemed necessary to resume for making roads, canals, bridges, towing paths, or other works of public utility or convenience, so nevertheless that such land so to be resumed should not exceed one-twentieth part in the whole of the Lands aforesaid. and that no such resumption be made of any land upon which any buildings might have been erected, or which might be in use as gardens or otherwise for the more convenient occupation of any such buildings. And whereas the piece or portion of land hereinafter described, now in the

occupation of one John Locke of Australind, Farmer, is necessary for the purpose of making of a public road and the same piece or parcel of land has been resumed accordingly. And the sum of ten pounds has been duly paid to the said John Locke by the Crown in respect of the value of the same, and of the improvements thereon. And the said John Locke has agreed to the said resumption. Now, Know Ye, that Her Most Gracious Majesty doth hereby and by virtue of the said powers and authorities reserved and contained in the said recited Deed Poll resumed for the purpose aforesaid, All that piece or parcel of land containing two acres, one rood, and two perches, more or less and being a portion of the said Leschenault location No. 1, being one chain wide on the West side of a line, about twenty two chains, sixty links in length, in a Northerly direction from a spot three chains fifty five links West from another spot about twenty-seven chains fifty links North, five degrees fifty-four seconds East, from the 8th mile post in the road as marked by Assistant-Surveyor F. T. Gregory from Bunbury to Peel.
