REFERRING to a notice published in the Government Gazette of the 1st Instant defining the boundaries of the Perth, Fremantle, and Swan Residencies, the following amended boundaries of the Perth, Fremantle, Swan, and Murray Residencies, as sanctioned by His Excellency the Governor in Executive Council, are published for general information.

PERTH RESIDENCY,

Bounded on the *West* by the Sea Coast; on the *South* by the North and East boundaries of North Fremantle Townsite, then by the Southern Shores of the Swan Inlet, and of the Canning River to the S. W. corner of Bull's Creek, then by a South Easterly line to that part of the Albany Road from Kelmscott lying East from the South boundary of Rockingham Townsite; on the *East* by a North Easterly line to Mount Dale, then by a North Westerly line to the East corner of Swan location 34, known as Belmont, then by the N.E. boundary of said location 34 prolonged N.W. to the Swan River's right bank, then by a line extending N. by W. to the East end of Lake Gnangarra, and then by a North line; and on the *North* by a West line to the Sea Coast through the North end of Lake Nowergup.—All bearings true.

FREMANTLE RESIDENCY.

Bounded on the *West* by the Sea Coast; on the *South* by a true East line from the South boundary of Rockingham Townsite to the Albany Road from Kelmscott; on the *East* by a North Westerly line thence to South West corner of Bull's Creek; and on the *North* by Bull's Creek, by the Canning River and Swan Inlet, and by the East and North boundaries of North Fremantle Townsite.—This Residency includes also Rottneet, Carnac, and Garden Island.

SWAN RESIDENCY.

Bounded on the *West* by the Sea Coast; on the *South* by an East line through the North end of Lake Nowergup, then by a South line through East end of Lake Gnangarra, then by a S by E line to Swan River's right bank at the upper boundary of Peninsula Farm, then by the upper boundary of Swan location 34, known as Belmont, and then by a South Easterly line to Mount Dale; on the *East* by a Northerly line from Mount Dale to the Half-way House (inclusive) on the York Road from Guildford, thence to Bailip (exclusive) on the Toodyay Road, thence to a spot 4 miles East from the Bridge at Bindoon, thence to the junction of the Muerin and Jilgin branches of Moore River, and by said Jilgin branch upwards to centre of Jilgin Pool in its bed; and on the *North* by a Westerly line to the Sea.—All bearings true.

MURRAY RESIDENCY.

Bounded on the *West* by the Sea Coast; on the *North* by an East line through South boundary of Rockingham Townsite to the Albany Road from Kelmscott, and by a North Easterly line thence to Mount Dale; on the *East* by a South Easterly line from Mount Dale to where the Albany Road from York crosses the Hotham, then by the River upwards to its source, and by an East line prolonged indefinitely; and on the *South* by an East line from the Sea, and through the summit of Mount William, to the Murray, then by that River and the Williams upwards, including the locations and leases on both banks of each, and by a line prolonged indefinitely to the East from Bannister Townsite; all bearings true.—This Residency includes also Penguin Island.

TO discourage the sending of coins by post, and to facilitate the transmission of small sums of money, notice is hereby given for the information of the public, that, on and after the first May next, provision will be made in the under-

IN reference to the arrival of Immigrants, shortly expected per "Mary Harrison," it is hereby notified for general information, that no person will be allowed to engage Immigrants until after they shall have been received into depôt either at Fremantle or Perth, where all applications must be made to the respective Immigration Agents, by whom every facility and information will be afforded.

No person will on any account be permitted to go on board the ship for the purpose of engaging Immigrants.

Persons residing at a distance from Fremantle and Perth, will authorise in writing agents at those places to make such arrangements as they may desire for the engagement and forwarding to them such Immigrants as they may require.

The local government will not in any way undertake the selection or transmission of Immigrants to rural districts.

The following Immigrants eligible for engagement are expected per "Mary Harrison."

About 100 single women.
30 married couples.
10 single men.
