PROCLAMATION.

By His Excellency John Stephen Hampton, Esquire. Governor and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies, and Vice-Admiral of the same.

Parliament of Great Britain and Ireland, passed in the 26th and 27th Years of Her Most Gracious Majesty's Reign, Chapter 76, intituled "An Act to determine the time at which Letters Patent shall take effect in the Colonies." It is amongst other things provided that the said Act shall take effect in each of Her Majesty's Colonies and Possessions so soon as the same shall be proclaimed therein by the Officer administering the Government thereof.

Now therefore If the said Governor do hereby proclaim and make known to all whom it may concern, the above-mentioned Act of the Imperial Parliament.
