PROCLAMATION.

By His Excellency John Stephen Hampton, Esquire, Governor and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies, and vice Admiral of the same.

WHEREAS by a notification in the *London Gazette* of Friday, the 9th day of September last, and dated "Foreign Office, September 8th, 1864. It was notified that Her Majesty had been pleased to order that for the future no Ship of War belonging to either of the belligerent powers of North America shall be allowed to enter or remain, or be in any of Her Majesty's Ports for the purpose of being dismantled or sold; and that Her Majesty had been pleased to give directions to the Commissioners of Her Majesty's Customs, and to the Governors of Her Majesty's Colonies and Foreign Possessions, to see that the said order be properly carried into effect.

Now therefore I the said Governor do hereby proclaim and make known to all whom it may concern, Her Most Gracious Majesty's said Order accordingly.

Given under my hand and the Public Seal of the Colony, at Government House, Perth, this eleventh day of November, 1864.

CONVEYANCE OF MAILS.

*Colonial Secretary's Office,
Perth, 20th September, 1864.*

TENDERS (in duplicate) endorsed "Tenders for conveyance of ——— Mail," (as the case may be), will be received at this Office until noon on Thursday, the 17th November, next, for the conveyance of the following Mails for three years, viz: from the 1st January, 1865 to the 31st December, 1867, (excepting Port Gregory, and Quindalup Mails which will be for 12 months only).

Between Perth and the half-way tree on the Fremantle road twice daily (in a spring cart or on horseback.)

Between *Fremantle and the half-way tree on the Perth road*, twice daily (in a spring cart or on horseback.)

Between *Guildford and Perth*, once daily (in a spring cart.)

Between *Guildford and York*, twice a week (in a spring cart.)

Between *Guildford and Newcastle* twice a week (in a spring cart.)

Between *York and Newcastle* via Northam twice a week (on horse back or in a spring cart.)

Between *Guildford and Upper Swan*, once a week (on horse back.)

Between *Bunbury and Blackwood* once a fortnight (in a spring cart or on horse back.)

Between *Perth and Busselton* via Pinjarrah, Australind and Bunbury, once a week (in a spring cart or on horseback.)

Between *Perth and Busselton* via Mandurah, Australind and Bunbury, once a week (in a spring cart or on horse back.)

Between *Busselton and Quindalup* (Saw Mill Station) either once or twice a week (on horseback.)

Between *Perth and Wanorenooka* via Gingin, Moore River, Yatheroo, Irwin River, Greenough and Champion Bay once a month (in a spring cart or on horseback.)

Between *Champion Bay and Port Gregory*, once a month (on horseback.)

Tenders offering to convey a mail in a spring cart will be preferred to those stipulating for its conveyance on horseback, where spring cart conveyance is to be used the contractor will occasionally on the requisition of the Postmaster General, be required to provide an Officer of the Post Office Department with a free passage.

The arrival and departure of Mails will be subject to instructions from the Postmaster General, and liable to alteration at any time during the year.

Two approved sureties will be required to join the contractors in a guarantee for the due fulfilment of the duties respectively contracted to be performed.

No payment will be made on account of any mail contract until the Bond has been signed by the contractor and his sureties, and any breach of contract in the wilful or negligent departure or delivery of the mails at the appointed days and hours will subject the contractor to the loss of a proportionate part of his pay, or the cancellation of his contract.

The contractors are to convey and deliver all mails which may be entrusted to them under the authority of the Postmaster General, or any of the Postmasters, and to provide, secure and water-tight lockers for mails in carts, and coverings for bags on horseback. The contractors moreover will be bound not to convey themselves, nor permit their servants to convey any letter or packet to the prejudice of the Post Office Revenue, under a penalty of £3, which penalty will be deducted from the monthly pay,

The persons employed by the contractors to convey the mails are to be subject to the approval of the Postmaster General both as to age and character.

NOTICE TO MARINERS.

TIDAL SIGNALS, RIVER YARRA.

MASTERS of Vessels and others navigating the River Yarra, are hereby informed that the Tidal Signals hitherto hoisted on board the *Sir Harry Smith* will, on and after the 12th instant, be discontinued, and the height of water in the Yarra be shown from that date by a self-acting tide gauge, erected on the outer red dolphin at the entrance of the river.

To assist persons on board vessels at a distance in ascertaining the height of water shown by the self-acting tide-gauge, six projecting arms are fixed on its south side, the upper edge of each arm, coinciding with the lower part of each figure on the face of the tide-gauge, which commence with the ten feet mark.

N.B.—The top of the indicator, as it is moved up or down by the tide, shows on the face of the gauge, the height of water over the shoalest part of the fairway.

NOTICE TO MARINERS.

LIGHTNING ROCKS, PORT PHILLIP HEADS.

In consequence of the frequent statements that have appeared in the public papers, that the rocks have been removed: Notice is hereby given that they still remain. The least water found on the shoalest head is eighteen (18) feet at low water.

The clearing marks for avoiding these dangers are as follow:—

Day Marks.

The Obelisk on Shortland's Bluff in line with east tangent of High Light, N. 32° E., clears them to the westward.

Point Lonsdale Flagstaff, open on either side of Point Lonsdale Telegraph House (white with a slate roof), clears them to the northward and southward.

Night Marks.

The light on Point Lonsdale showing green about N. W. by N. leads south of them. The same light showing red from W. N. W. to W. by N. leads north of them.

[All bearings are magnetic. Variation 8° 16 east.]
