SHIP "HUDSON,"

Bound from Sunderland to King George's Sound October 5th, 1864, at 8 a.m. Civil time, passed a Shoal extending N.N.W. and S.S.E. about one mile in length with heavy breakers on it, also a rock about twenty yards in length and ten feet high, the Shoal bore S.S.W. from the Ship distant one mile. By good observations this Shoal is in Lat. 39° 52' S., Long., 35° 13' E. from Greenwich.
