PROCLAMATION.

By His Excellency John Stephen Hampton, Esquire, Governor and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies, and Vice Admiral of the same.

HEREAS it is expedient to establish a New Town in the North District to be called the Town of ROEBOURNE. Now know YE that I, the said Governor, in pursuance of the authority in me vested, do hereby declare and proclaim that the Town of Roebourne shall consist of all that piece or parcel of land situate in what is at present known as the North District of the said Colony, containing Two thousand and Ninety-five acres more or less, and bounded as follows, that is to say, on the North by a true east line of one hundred and forty-four chains from a spot about eight hundred chains south, and about forty chains West from the north extremity of Cape Lambert, the said north boundary including also on its south side the whole of Roe Island; on the West by a true south line of one hundred and forty-four chains from the spot aforesaid; on the South by a line parallel and equal to the north boundary; and on the East by a line parallel and equal to the west boundary; a boundary mark being fixed in the ground at each corner of the square figure above described

Given under my hand and the Public Seal of the said Colony, at Government House, Perth, this 17th day of August, 1866.
