PROCLAMATION.

By His Excellency John Stephen Hampton, Esquire, Governor and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies, and Vice-Admiral of the same.

HEREAS by a Proclamation under my hand and the seal of the said Colony, bearing date the Seventeenth day of August last, I did declare and proclaim that the Town of Roebourne, in the North District of the said Colony, should contain Two thousand and Ninety-five acres, more or less, and bounded as in the said Proclamation is particularly set forth; And whereas it has been deemed expedient to vary the area and boundaries of the said Town: Now know all Men that I the said Governor, in pursuance of the authority in me vested, do hereby declare and proclaim that the said Town of Roebourne shall consist, not of the area and boundaries in the said recited Proclamation set forth, but of the following area and boundaries; that is to say: -All that piece or parcel of land situate in what is at present known as the North District of the said Colony, and containing One thousand Nine hundred and Twenty acres, more or less, bounded on the North by a due east line of ninetysix chains from a spot about six hundred and eighty-two chains South, and about forty chains West from the North extremity of Cape Lambert; on the West, by a true South line of two hundred chains from the spot aforesaid; on the South, by a line parallel and equal in length to the North boundary; and on the East, by a line parallel and equal in length to the West boundary ;—a boundary mark being fixed in the ground at each corner of the figure above described. And I do also further deelarc and proclaim, that all the Waste Lands of the Crown comprised within the limits of Eighty chains from the North, East, and

South sides of the Townsite of Roebourne, as hereby defined, shall be held in reserve for sale and disposal by the Crown as Suburban Lots; and as Commonage for the use of the holders or occupants of Land within the said Townsite and its Suburbs, under such regulations as are now, or shall be from time to time hereafter, promulgated in that behalf by due and competent authority.

Road between Albany and the Kalgan River Ferry, &c.

T is hereby notified for general information, that it is the intention of the Government to lay out, clear and make, as soon as convenient, a line of road between the Town of Albany and the present road to Jerramungup, by way of the mouth of King River and the Kalgan River Ferry, with a view to the same being opened for use as a public line of communication, pursuant to the provisions of existing Ordinances :—

The road will be half a chain in width and, commencing at the east end of North Street in Albany, will extend eastward on the north side of Craggy Bluff to the south corner of Plantagenet location 43, then inside the northern boundary of Albany Townsite, and north north-eastward to the bridge over Yakama Brook, thence northeastward along the ridges to the middle of the west boundary of location 7, and thence more easterly to Point Henty at the mouth of King River. Crossing the ford there, the road will extend to the NW corner of location 28, then outside its north boundary and through location 21 to the ferry across Kalgan River .-- Crossing at the said ferry, the road will run through the SE corner of locations 51, 53, and 5, and then north-easterly to the present road which extends eastward from the Windham Brige across the Kalgan.

The above road will pass as near as may be found desirable along the tracks at present in use; and all persons are warned against fencing across or otherwise obstructing the said tracks, until the permanent lines may be finally laid out and cleared.
