#### PROCLAMATION.

By His Excellency John Stephen Hampton, Esquire, Governor and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies, and Vice-Admiral of the same.

HEREAS it is enacted by the www second Section of the "Small Debts Ordinance, 1863," that it shall be lawful for the Governor from time to time, and at any time by Proclamation published in the Western Australian Government Gazette, to constitute Local Courts for the recovery of Small Debts and Demands to be holden at such times and places, and within such Districts throughout the said Colony as may be most fit and convenient, and as may be specified in such Proclamation, and likewise by Proclamation to alter the time, or place, or manner of holding any such Courts, and that it has been deemed expedient to alter as hereinafter specified the time for holding the Local Court at Perth;

Now THEREFORE I, the said Governor, in exercise of such power, do hereby notify and proclaim that from and after this date the Local Court at Perth shall be holden on the last Thursday in each month.

TN PURSUANCE of the authority in me vested by the 16th Section of an Ordinance passed in the 19th year of the Reign of Her Majesty Queen Victoria, No. 15, intituled "An Ordinance to consolidate "and amend the Laws respecting the "Licensing of Boats and Boatmen," I do hereby notify and proclaim that the undermentioned Regulations are and shall be additional Regulations to be observed for the preservation of the South Bay Public Jetty at Fremantle, until altered or amended as occasion may require.

Additional Regulations for the management of the South Bay Public Jetty at Fremantle.

- 1.—From the date of the promulgation of these Regulations, the Tramway constructed on the South Public Jetty shall be used for the transit of Goods and Merchandize, on, to, and from such Public Jetty.
- 2.—Any wheeled Vehicle, drawn by any quadruped or quadrupeds, shall not be permitted to go on such Public Jetty.
- 3.—The Tramway and Trucks on such Public Jetty shall be managed by a Committee of four, viz.:—Mr. Walter Bateman, Mr. William Dalgety Moore, Mr. Edward Newman, and Mr. Charles Rosmore Hunt, who shall have the entire control thereof; and no person shall use or move the trucks without the permission of the Committee, or person acting for them.
