BUSSELTON—WARREN ROAD.

*Colonial Secretary's Office,
Perth, 16th June, 1868.*

IT is hereby notified for general information, that a Public Road, one chain wide, has been laid out and opened for traffic, between the Townsite of Busselton and the Warren River Bridge just above Treen's Brook.

Commencing at the end of the causeway at S.E. corner of Busselton Townsite, the road will extend Easterly about a quarter of a mile, then generally S.E. $\frac{1}{2}$ E. 10 miles and E.S.E. $\frac{1}{2}$ S. $11\frac{1}{2}$ miles, to the Bridge over Saint John's Brook, a little above Sussex location 28; then S $\frac{3}{4}$ E. 6 miles and S.S.E. $\frac{1}{2}$ E. 6 miles to the lower Blackwood Bridge midway between location 15 and the mouth of Nannup Brook. Thence it takes the general direction of S. $\frac{1}{2}$ E. 9 miles and S. $\frac{3}{4}$ W. 9 miles to a bridge over Barlee Brook, then S. $\frac{1}{4}$ E. $3\frac{1}{4}$ miles to a bridge over a Gully, and S. by E. $\frac{1}{2}$ E. $3\frac{1}{4}$ miles to Beeribellup Ford over the main branch of Donnelly River, which here runs to the S.W. The road then extends S. by E. 3 miles and South-easterly $3\frac{1}{4}$ miles to Caragodup Brook half a mile above its junction with Carey Brook. It then winds Easterly and Southerly for $2\frac{1}{4}$ miles to Beedelup Falls in Carey Brook, then to the Eastward and S.E. $3\frac{1}{4}$ miles to Fly Brook at the 37th mile mark from the lower Blackwood bridge, then S.E. 1 mile and E. by S. 3 miles to a bridge over Treen's Brook one mile above its junction with Warren River.—Four or five chains to the Southward of Treen's bridge the road joins the Warren and Bunbury road, and then extends along said road half a mile S.W. by S. to the N.E. corner of Nelson location 46, and finally through that location about 35 chains in a South-westerly direction to the bridge over Warren River, a little above the mouth of

Treen's Brook. All bearings true or thereabouts, and measurements more or less.

Between the lower Blackwood Bridge and the Warren Bridge, the road is marked by numerous blazed Trees, and by marked Trees at every mile.

BRIDGETOWN and WARREN ROAD.

IT is hereby notified for general information, that it is the intention of the Government, as soon as means may be available for the purpose, to survey and lay out a public road, one chain wide, between the Blackwood River bridge at Bridgetown and the Warren River bridge just above Treen's Brook.

Commencing at a spot on the south boundary of the Townsite of Bridgetown bearing nearly south from the Blackwood River bridge in Bridgetown, the road will pass in a southerly direction to the westward of Nelson locations 44 and 63, and then south-easterly about $1\frac{1}{2}$ miles along the present made road to a bridge over Forrest Brook, ascending then its eastern bank, and extending for about 10 miles in a direction generally SSE and South to the western side of locations 17 and 62 at Wilgarrup. The road will then diverge for about $7\frac{1}{2}$ miles to the SSW, to the SE corner of location 31 at Manjimup, after throwing off a short branch to location 32 at Ballarup, where is stationed the present District Post Office. From Manjimup it will take a general SW by S and S by W direction for 9 and 7 miles to location 73, passing through and beyond which in a general SSW direction for $4\frac{1}{2}$ miles, it will then join the road from Busselton to the

Warren River bridge 4 or 5 miles southward from Treen's bridge which crosses a brook of the same name. Thence the road follows the route to the Warren bridge described in a Gazette notice dated 16th June, 1868. All bearings true.

More full particulars will be published in a future notice after the road shall have been surveyed and laid out. The public are in the meantime cautioned against fencing across or otherwise obstructing the road in use.
