## GREETING:

KNOW YE that We have assigned you jointly and severally and every one of you Our Justices to keep Our Peace in Our Colony of Western Australia. And to keep and cause to be kept all Ordinances and Statutes for the good of the Peace and for the preservation of the same and for the quiet rule and government of Our People made in all and singular their Articles in Our said Colony (as well within Liberties as without) according to the force form and effect of the same. And to chastise and punish all Persons that offend against the form of those Ordinances or Statutes or any one of them in the aforesaid Colony as it ought to be done according to the form of those Ordinances and Statutes. And to cause to come before you or any of you all those who to any one or more of Our People concerning their Bodies or the fring of their Houses have used threats to find sufficient security for the Peace or their good behaviour towards Us and Our People. And if they shall refuse to find such security then them in Our Prisons until they shall find such security to cause to be safely kept.

We have also assigned to you and every two or more of you (of whom any one of you the aforesaid Archibald Paull Burt, George Frederick Stone, Edward Wilson Landor, Joseph Strelley Harris, George Eliot, Samuel Waterman Viveash, Walkinshaw Cowan, Sir Alexander Thomas Cockburn Campbell, Alfred Durlacher, John Gray Murray, Robert John Sholl, Maitland Brown, William John Clifton, John George Slade, We will shall be one) Our Justices to inquire the truth more fully by the oath of good and lawful Men of the aforesaid Colony by whom the truth of the Matter shall be the better known of all and all manner of Felonies, Poisonings, Trespasses, Forestallings, Reagratings, Ingrossings and Extortions whatsoever. And of all and singular other Crimes and Offences of

which the Justices of Our Peace may or ought lawfully to inquire by whomsoever and after what manner soever in the said Colony done or perpetrated or which shall happen to be there done or attempted. And also of all those who in the aforesaid Colony in Companies against Our Peace in disturbance of Our People with armed force have gone or rode or hereafter shall presume to go or ride. And also of all those who have there lain in wait or hereafter shall presume to lie in wait to maim or cut or kill Our People. And also of all Victuallers and all and singular other persons who in the abuse of Weights or Measures or in selling Victuals against the form of the Ordinances and Statutes or any one of them therefore made or in force for the common benefit of the said Colony and Our People thereof have offended or attempted or hereafter shall presume in the said Colony to offend or attempt. And also of all Sheriffs, Bailiffs, Stewards, Constables, Keepers of Jails and other Officers who in the execution of their Offices about the Premises or any of them have unduly behaved themselves or hereafter shall presume to behave themselves unduly or have been or shall happen hereafter to be careless remiss or negligent in our aforesaid Colony. And of all and singular Articles and circumstances and all other things whatsoever that concerns the said Colony done or perpetrated or which hereafter shall there happen to be done or attempted in what manner soever. And to inspect all Indictments and Informations whatsoever so before you or any of you taken or to be taken or before others late Our Justices of the Peace in the aforesaid Colony made or taken and not yet determined. And to make and continue Processes thereon against all and singular the Persons so indicted or information against or who before you hereafter shall happen to be indicted or informed against until they can be taken surrender themselves or be outlawed. And to hear and determine all and singular the Felonies, Poisonings, Trespasses, Forestallings, Regratings, Ingrossings, Extortions, Unlawful Assemblies, Indictments and Informations aforesaid, and all and singular other the Premises according to the Laws and Ordinances of the said Colony as in the like case it has been accustomed or ought to be done. And the same Offenders and every of them for their Offences by Fines, Ransoms, Imprisonments, Amerciaments, Forfeitures, and other means as according to the Law and Custom of the said Colony or form of the Ordinances and Statutes aforesaid it has been accustomed or ought to be done to chastise and punish.

PROVIDED ALWAYS that if a case of difficulty upon the determination of any of the Premises before you or any two or more of you shall happen to arise. Then let Judgment in no wise be given thereon before you or any two or more of you unless in the presence of Our Chief Justice of Our said Colony. And therefore We command you and every of you That in the keeping of the Peace Ordinances and Statutes and all and singular other the Premises you diligently apply yourselves and that at certain days and places appointed for these purposes into the Premises you make inquiries and all and singular the Premises hear and determine and perform and fulfil them in the aforesaid form doing therein what to Justice appertains according to the Law and Custom of the said Colony saving to Us the Fines and other things to Us therefrom belonging.

AND WE COMMAND by the tenor of these Presents Our Sheriff of Western Australia that at certain days and places which you or any such two or more of you as is aforesaid shall make known to him he cause to come before you or such two or more of you as aforesaid so many and such good and lawful Men of his Bailiwick by whom the truth of the Matter in the Premises shall be better known and inquired into.

IN WITNESS whereof We have caused Our trusty and well beloved Frederick Aloysius Weld Esquire Our Governor of Our said Colony to sign these Presents and to affix hereto the Public Seal of Our said Colony this first day of October in the thirty-third year of Our Reign, and in the year of our Lord one thousand eight hundred and sixty-nine.

## £5000 REWARD !!

IT is hereby notified for general information, that the Local Government of Western Australia offer as a Reward for the discovery of a workable GOLD FIELD within a radius of Three hundred miles from any declared port in the Colony, on or before the 31st day of December, 1869, the sum of

## CONVEYANCE OF ALBANY MAIL.

*Colonial Secretary's Office,  
Perth, 17th August, 1869.*

TENDERS (in duplicate) endorsed "Tenders for Albany Mail," will be received at this Office until noon of Wednesday, the 24th November, 1869, for the conveyance of Colonial and Foreign mails from Perth to Albany and *vice versa*, twice

a month for three years, commencing on the 1st January, 1870.

The contractor will be required to convey the mails at such dates in each month as the Postmaster General shall fix.

Parties tendering must state the time in which they will undertake to convey the mails from Perth to Albany and *vice versa*.

The tender stipulating to convey the mails in the shortest time will be preferably considered.

In case the contractor should fail to deliver the mails at either Perth or Albany within his contract time, in consequence of the overloading of the mail cart with passengers or luggage, &c., he will be liable to a penalty not exceeding £20—exclusive of any sum recoverable by his bond.

In the event of the mail packet discontinuing to touch at King George's Sound during the period of the contract, the unexpired portion of it will be cancelled.

The arrival and departure of mails will be subject to instructions from the Postmaster General, and liable to alteration at any time during the contract.

The contractor will be required to provide an officer of the Post Office with a free passage to and from Albany, if called upon to do so at any time by the Postmaster General.

Two approved sureties will be required to join the contractor in a guarantee for the due fulfilment of the contract.

No payment will be made on account of the contract until a bond shall have been signed by the contractor and his sureties, and any breach of contract will subject the contractor to the loss of a proportionate part of his monthly pay, or the cancellation of his contract.

The contractor will be required to convey and deliver all mails which may be entrusted to him under the authority of the Postmaster General, and to provide secure and water-tight lockers for the mails, and coverings for the same. He will, moreover, be bound not to convey, or permit his servants to convey any letter or packet to the prejudice of the Post Office Revenue, under a penalty of £3 for every offence, which penalty will be deducted from his monthly pay.

The persons employed by the contractor to convey the mails are to be subject to the approval of the Postmaster General both as to age and character.

Further particulars may be obtained on reference to the Postmaster General, at whose office forms of tender may be obtained, as well as from the Resident Magistrates of the various districts.

#### Murray Bridge to South Dandalup Bridge.

**I**T is hereby notified for general information that a Public Road, one chain wide, has been laid out and opened for traffic between the Murray River bridge at Pinjarra and the bridge over South Dandalup River where it is crossed by the road to Perth:—
