## SECTION 79.

“No paid Officer under the Government of a Colony can be permitted to be the Editor of a newspaper or to take any active part in the management of it. He may furnish articles signed with his name upon subjects of general interest, abstaining from writing on questions which can properly be called political, or discussing the measures of the Government or the official proceedings of its officers and from furnishing any articles whatever to a newspaper which in commenting on the measures of the Government should habitually exceed the bounds of fair and temperate discussion. If the authorship of anonymous articles should be brought home to any officer, or if in articles bearing

"his signature he should discuss  
 "any political subject, or the mea-  
 "sures of the Government or the  
 "official proceedings of its officers, he  
 "will be liable to be removed from  
 "office."
