IS Excellency The Governor has been pleased to approve of the following Regulations to be observed in the management of the Receiving Store connected with the Customs House at Fremantle, commonly known as "A Store."

1. The Building to be under the Control and Supervision of the Customs Department.

2. It will be open each day from 7 a.m. to 8 a.m., and from 10 a.m. to 4 p.m. daily, except Saturdays, when it will be closed at noon.

3. No Timber, Coals, Gun Powder, Kerosene, Bricks, Iron, Stone, Tar, Hay (except hay the property of the Government), nor any other material or substance that in the opinion of the Collector of Customs for the time being may be considered of a dangerous nature, or likely to damage either the Store or the Goods in it, shall be stowed therein.

4. All Goods to be stowed in such places as may be pointed out by the Officer in Charge of the "Receiving Store," at the risk and expense of the depositor, and no goods removed without his sanction.

5. All Goods approved by the Collector of Customs, with the exceptions named in Rule No. 3, may be deposited in "A Store," at the following rates of charges :---

Special cases will be decided by the Collector of Customs.

6. All Goods after 3 months' deposit may, at the discretion of the Collector of Customs, be advertised for two clear weeks, and if not claimed and cleared, may be submitted to Public Auction; and from the sum realised it shall be lawful for the Collector of Customs to carry to the credit of the Government the full rent and any charges due, and hand over the balance to the owner or his agent, if claimed within 12 months from date of sale.

7. Smoking and the use of lucifer matches strictly prohibited inside the building.

THE following By-Laws for regulating the proceedings of the York Municipal Council, have been confirmed by His Excellency the Governor, with the advice of his Executive Council.

By-Laws unanimously agreed to by the Muni-cipal Council of York at a Meeting held on the 13th July, 1871.

RESOLVED—That in accordance with the 28th Section of "The Municipal Institutions' Act, 1871," the following By-Laws be now adopted by the York Town Council, for the regulation, management, and control of the several matters and things therein set forth, viz. :-

The York Town Council shall meet in the Mechanics' Hall, for the transaction of business, on the first Thursday in every month, or oftener if necessary.

2. Until the state of the funds will warrant the employment of a Supervisor-the Chairman with the advice of the Council shall have the immediate custody, care, management, and direction, of all Buildings, Lanes, Streets, Paths, Trees, Plants, Posts, Fences, Works, Drains, Culverts, and other property over which the "Municipal Institutions' Act, 1871," gives them control.

3. The Collector for the time being, appointed by the Council, shall have the necessary legal power and authority to demand and collect all Rates, Assessments, License fees, Fines, Forfeitures, Tolls, and other sums due to the Council, and his receipt shall be a full and sufficient discharge for the same. And all sums so collected shall be paid to the Treasurer (or in case of the Treasurer's absence to the Chairman) on the last day of every month (or oftener if required) under a penalty of any sum not exceeding £10.

4. Any person who shall keep for 7 days, within the boundary of the Town, and depasture the same on Town or Crown Lands, any cattle, sheep, or goats, without having obtained a License signed by the Chairman of the Council, shall forfeit and pay for every such offence any sum not exceeding one pound.

5. Any person who shall herd Cattle within the jurisdiction of the York Town Council, and who shall neglect to furnish the Chairman with a correct quarterly statement of the number of Cattle in his herd, and their owners' names, shall forfeit and pay any sum not exceeding $\pounds 5$.

6. Any owner or other person who shall wilfully or negligently allow any horse or other live stock to stray or be at large without a keeper within the Town boundary, shall forfeit and pay for every such offence the following fines, in addition to Pound fees and damage by trespass :-

SCALE OF FINES.

1st.—For each Entire Horse or Bull at large by day, not less than £2 nor more than £4.

2nd.—For ditto ditto by night, not less than £3 nor more than £5.

3rd.—For every Horse, Cattle, or other live stock by day, not less than 5s. nor more than 20s.
4th.—For ditto ditto by night, not less than 10s. nor

more than 40s.

7. Any person who shall keep for 7 days within the boundary of the Town a Dog above the age of six months, without having obtained a License signed by the Chairman, shall forfeit and pay for every such offence any sum not less than £1 nor more than £5.

SCHEDULE OF FEES FOR DOG LICENSE.

1. For every Dog above the age

of 6 months 7s. 6d. per annum. For every Bitch do. do. ... 10s. " 2.

8. All Licenses issued by the Chairman of the York Town Council shall continue in force until the 31st of December in each year.

9. Any person who shall in the course of trade or business, within the boundaries of the Town, use any false, or any deficient weights or measures, shall forfeit and pay for every such offence any sum not exceeding $\pounds 10$.

10. Any person who shall, within the boundaries of the Town, sell any unlawfully-adulterated spirituous or fermented liquors, shall forfeit and pay for every such offence any sum not exceeding £50.

11. Any person who shall sell or offer for sale, within the boundaries of the Town, any Meat, Fish, or Vegetables, unfit for human food, shall forfeit and pay for every such offence any sum not exceeding $\pounds 10$.

12. Any owner or occupier of any land, house, or premises, within the Town boundary, who shall neglect or refuse for fourteen days after due notice from the Chairman of the Council, to abate or remove all nuisances which are or shall arise thereon, or to remove any inflammable building, or pile or stack of wood, or other material dangerous to the adjoining or contiguous property, shall forfeit and pay for every such offence any sum not exceeding £10.

13. Any person who shall (without first having obtained the written sanction of the Chairman of the Town Council) cut down, damage, destroy, or injure any Tree, Plant, Post, Fence, Gate, Drain, Water-course, Culvert, Building, or other property belonging to or in charge of the Council, shall forfeit and pay for every such offence any sum not exceeding £10.

14.Any owner or occupier of any House, Shop, Store, or other building within the Town boundary, whose roof shall overhang over any thoroughfare or footway without having a proper gutter and pipe to carry off the rain, or who shall construct or have any Cornice, Crane, or Hoist, or any other fixture or projection overhanging any footway or thoroughfare, shall forfeit and pay for every such offence any sum not exceeding £5 for every month such nuisance shall remain after fourteen days' notice to remove the same shall have been given in writing by the Chairman of the Town Council.

15. That whenever the term "Town Bound-aries" or "Boundaries of the Town" occurs in these By-Laws, it shall be taken to mean "Boundary of the Municipality of York."
