Lands for Special Occupation.

Land Office, Perth, 21st June, 1872.

THE several Areas of land hereinafter described save and arrest m described, save and except Townships, Alienated Lands, Reserves, Tillage Leases, and Mineral Lands within such definitions, are hereby laid out and defined in accordance with the provisions of number thirty-seven of the Land Regulations now in force; but the said definitions and limitations are subject to such amendments, additions, adjustments, cancellations, or alterations as may be considered from time to time or at any time desirable or necessary; and further in regard to such lands, no rights or

privileges, allowed by number thirty-eight of the Land Regulations aforesaid, in respect to Commonage, are to be deemed conferred specially or necessarily in any case to any applicant or applicants for land within these areas, in regard to which this is a sufficient notification.

XXIX.—SWAN DISTRICT (Branson's near Bindoon.)
