RAILWAY SURVEYS.

FIGURE OF SECOND EACH OF SECOND EAC

1. An Engineering Survey of a proposed line of Railway (to be of a gauge of 42 inches) between Geraldton, Champion Bay, and Northampton, a distance of about thirty-two miles. The work to comprise all surveying, levelling, planning, and specifying necessary for the setting the whole work by Contract.

The Survey to be tendered for at per mile, and Tenders to state whether bridges and culverts are included therein, or separately offered at per foot.

2. A preliminary Survey for a similar line of Railway from Guildford to York, a distance somewhat in excess of eighty miles, the general route of which has already been determined on.

To include a properly benched Survey, with longitudinal section of the whole line, to show generally the measurement of all bridges and culverts, but not detail drawings or specifications.

Tenders for the above Services to include all instruments, plant, and labor; and the work in each case to be completed and plans furnished on or before the first day of June, 1873.

DESCRIPTION OF MAIN AND MINOR ROADS IN NORTHAM DISTRICT. MAIN ROADS.

- 1. The Road leading from the Bridge across the Avon River at Northam, towards Guildford, to the South-western boundary of the District.
- 2. The Road leading from Northam towards Newcastle, on the Western side of the River Avon.
- 3. That part of the Road leading from the Bridge over the Mortlock River towards York, from the Eastern boundary of Northam Townsite to the boundary of the District.

MINOR ROADS.

- 1. The Road leading from the Mortlock River Bridge, along the East side of the Avon River, from the Northwest boundary of Northam Townsite to Katerine or Viveash's Causeway.
- The Road extending Northward from Nor-tham Church, from the Northwest bound-ary of the Townsite, via Greenhills, to Sinclair's Causeway.
- 3. The Road branching off from the Northam and York Road (Main Road No. 3) near Morrell's, and leading to Grass Valley.
- 4. That portion of the Road from Northam to York, extending about Southwest from the Western boundary of the Townsite, and after crossing the Avon River near Barralong Pool, runs in a South-easterly direction to the boundary of the District.
- 5. The Road leading from Northam to Nulgageering.
