Report of amount of work performed by the Town Party, Albany, under the Officer appointed by the Council, from 1st day January, 1872, to 30th day of November, 1872:—

No. of men employed, 6½ per day.
New road laid down in Frederick Street, 1396 yards super.

Stone gutter set, 143 yards super; foot path made, 429 yards super; stone kerb to do, 143 yards super.; 1 dish drain set, 120 yards super.; stone quarried, broken, and spread, 409 yards cube.

Gravel got and spread, 230 do. do; earth and sand removed, 520 do. do.

In addition to the above work all the roads and drains in the town, from Spencer Street to Parade Street, have been from time repaired and cleared as required.

The plan laid down for the year 1873 is as under:—

1. Finish Frederick Street as far as Spencer Street.
2. Put in a stone drain on the West side of Stirling Street, and make good the roadway where required.
3. Construct a culvert or dish drain in Duke Street, to carry the water from Stirling Street into lot 39.
4. Level a new road (to be called "Council Road"), ½ chain wide, through Lot No. 39, the said lot being the property of the corporation; the road to run from N. to S., and to commence from the E. side of the lot next to lot No. 38.
5. Put in a rough stone drain on the E. side of "Council Road," to carry the water into Stirling Terrace; and make good all drains in Stirling Terrace.
