CLASSIFICATION OF ROADS.

MAIN.

1. The Road from Northampton, by the Bowes Bridge, Kobijawanna, and Table Hill, to Oakagee and Buller Bridge, towards Champion Bay.
2. The Road from Kobijawanna by Knockanena farm, the Wheel Fortune Mine, to Port Gregory.
3. The Road from Northampton by Knockbrack, Norman's Well, Nabawah Pool, and Narra Tarra, to Mr. M. Morrissey's, towards Nabagee. Hunt's line.
4. The Road from Northampton to the Geraldine Mines, *via* Stone Hut Station and Desert Spring.
5. The Road from the Desert Spring Well to Port Gregory, by Mr. Nancarrow's Farm and Lynton.
6. The Road from the "White Peak" by the Walloby Pool, Nabawah Pool, in an Easterly direction towards Talyering.

MINOR.

1. The Road from the Oakagee by Oakabella, West of King's Table Hill, and over the Bowes River to Northampton Townsite.
2. The Road from the Wheel Fortune Main Road to Walla Gully.
3. The Road from the Wheel Fortune to Northampton Townsite, *via* Knockanena farm.
