S.O.L.-MELBOURNE DISTRICT (Ashton's).

Bounded on the South and West by lines extending 40 chains East and 25 chains North from a spot distant 3 chains South and I chain West from a Native Well, said well being situate about 20 chains South and 120 chains West from the South-west corner of Melbourne Location 233. The opposite boundaries being parallel and equal. Content—100 acres.

S.O.L.-AVON DISTRICT (Cahill's).

Bounded on the Southward and Eastward by lines extending 50 chains Westward and 20 chains Northward from a spot 4 chains Eastward from the North-west corner of Avon Location 322. The opposite boundaries being parallel and equal. Content -100 acres.

S.O.L.-AVON DISTRICT (J. & W. Cousins').

Bounded on the Northward by an Easterly line of 35 chains 72 links from the North-east corner of Avon Location 431. On the Eastward by a Southerly line of 24 chains. On the South-ward by a Westerly line of 50 chains and on the Westward by a North-north-west line of 10 chains, by an East-north-east line of 14 chains 28 links, and a North-north-west line of 14 chains to starting point. Content—100 acres.

S.O.L.-AVON DISTRICT (J. MeL. Dempster's).

Bounded on the Southward and Westward by lines extending Eastward 20 chains and Northward 50 chains from a spot 70 chains East-northeast and 10 chains North-north-west from the South-west corner of Pastoral License 7032, and by opposite boundaries parallel and equal; all bearings magnetic. Content—100 acres.

S.O.L.-AVON DISTRICT (Murphy's).

Bounded on the Northward and Eastward by lines extending Westward 25 chains and Southward 40 chains from a spot about 20 chains South-south-east from the South-east corner of Tillage Lease 7277. The opposite boundaries being parallel and equal. Content—100 acres.

S.O.L.-AVON DISTRICT (Stevenson & Harris').

Bounded on the North and East by lines extending West 25 chains and South 40 chains from a spot 10 chains East from the South-west corner of Tillage Lease 6727, at Wickepin. The opposite boundaries being parallel and equal. Content-100 acres.

S.O.L.-AVON DISTRICT (A. & F. Smith's).

"Any Conditional Release Holder who shall be convicted before any one or more Justice or Justices of the Peace of selling or retailing, either for himself or for any licensed or unlicensed person, any ale, beer, wine, or other spirituous or fermented liquor, or of being retained or employed in the care, charge, conducting, or management of any house or place in which a Publican's General License, a Wine and Beer License, or a Wayside House License is exercised, shall at once forfeit his Conditional Release, and shall be liable to be remitted to prison and to revert to his original sentence of Penal Servitude."
