HEREAS the Legislative Council now stands prorogued until Saturday, the twenty-fourth day of July instant, and whereas it is expedient further to prorogue the same; Now THEREFORE I, the said Governor, in exercise of the powers in me vested, do by this my Proclamation further prorogue the said Legislative Council from Saturday, the twentyfourth day of July, until Tuesday, the twentyfourth day of August, now next ensuing.
