It is hereby notified with reference to the advertisement of the 8th June, 1874, that the Government of India are prepared to purchase about 1,000 horses, suitable for army purposes, during the year 1875-76.

The purchases will be made by Remount Agents or Committees as in previous years at the stations named in the margin.

The purchases will, except under any special circumstances, be made only between the 1st October and 1st April.

The requirements of 1876-77 will be 600 horses more or less.

Horses and mares of all breeds will be received, and they must be within the prescribed age—four to seven years.

The average price for a remount has been fixed at Rs. 550. Every horse presented for purchase will be valued separately, and higher or lower prices may be given, provided that the average of the purchases does not exceed that limit.

**S.O.L.—MELBOURNE (*Bower's*).**

Bounded on the *North* and *East* by lines extending West 30 chains, and South 53 chains 33 links, from a spot 16 chains North, and 15 chains East, from the centre of Waleevin Swamp, the said swamp being situate about 6 miles South from Bulgamarra Spring; the opposite boundaries being parallel and equal, and bearings true. Content—100 acres.

**S.O.L.—NELSON (*Calder's*).**

Bounded on the *North* and *East* by lines extending West 18 chains 25 links, and South 54 chains 75 links, from a spot 5 chains East from a red gum tree marked LC, the said tree being situate about 39 chains South from the South-east corner of Nelson Location 14; the opposite boundaries being parallel and equal, and bearings true.
