## F0RTY-FIRST NOTIUE.

WELLINGTON (Stevens'),-100 acres.
North by 69 chains 75 links of the South boundary of Wellington Location 9, extending West from the North-west corner of Tillage Lease 7143. Wast by a South line of 24, chains 80 links; and South-west by the Road from Bunbury to the Upper Ferguson.

PLANTAGENET (Blackburn's).-100 acres.
Starting from the North-west corner of the Reserve at the Gordon River Bridge, and extending South 8 chains, then West along the North bank of the Gordon River downwards about 30 chains, then North 32 chains, East 23 chains, then in a Southeasterly direction along the South-west side of PerthAlbany Road to the North boundary of aforesaid Reserve, then by a West line of 12 chains to the starting point. Measurements more or less.

WELLINGTON (Higgins', No. 1). -100 acres.

WELLINGTON (Gardiner's).-100 acres.
North by an East line of 45 chains from the Northeast corner of Wellington Location 198. West by a South line of 22 chains 22 links; the opposite boundaries parallel and equal.

WILLIAMS (McKenna's).-100 acres.
North and West by lines extending East 25 chains and South 40 chains from a spot on the East boundary of Location 46, at the distance of 4 chains North from its South-east corner; opposite boundaries parallel and equal.

MELBOURNE (MacPherson's).- 100 acres.
North and West by lines extending East 54, chains 75 links, and South 18 chains 25 links from a spot 120 chains East and 9 chains 13 links North from Bourbana Well in Location 119; opposite boundaries parallel and equal.

VICTORIA (Eakin's)-200 acres.
North-east and North-west by lines extending Southeast 50 chains along Kennedy Road and South-west 40 chains from the North-east corner of Tillage Lease 5135 ; opposite boundaries parallel and equal.

VIOTORIA (Connolly's).-200 acres.
South-west and North-west by lines extending Southeast 40 chains along the Arthur Road, and Northeast 50 chains from the Southern corner of Pensioners' Lot 53, on the Upper Greenough Flats; opposite boundaries parallel and equal.

VICTORIA (Mrs. Silcocl's).-150 acres.
South-west and North-west by lines extending Southeast 30 chains along the Arthur Road, and North-east 50 chains from the Southern corner of S.O.L. 676; opposite boundaries parallel and equal.

VICTORIA (Tomlinson's).-100 acres.
North and East by lines extending West 40 chains and South 25 chains from a spot 14. chains South from the North-west corner of Location 201; opposite boundaries parallel and equal.

VICTORIA (Warren's, No. 1).- 120 acres.
East by the West boundary of Tillage Lease 5312. North by the Chapman River. South by a West line of 22 chains 64 links; and West by a line extending South from the Chapman River about 43 chains to the West end of the South boundary. Measurements more or less.

VICTORIA (Warren's, No. 2).-100 acres.

North and East by lines extending West 47 chains 42 links, and South 47 chains 42 links, from a spot 11 chains 21 links East from the South-east corner of Tillage Lease 5999 ; opposite boundaries parallel and equal.

VICTORIA (Waldeck's)-197 acres.
South by the North boundary of Tillage Lease 7252, measuring about 36 chains. West by about 55 chains of a public road. North by the South bound. ary of Tillage Lease 6833, measuring about 35 chains; and on the East by about 55 chains of the West boundary of Location 442. Measurements more or less.

Northward and Eastward by lines extending West-south-west 25 chains, and South-south-east 40 chains from a spot 32 chains South-south-east and 26 chains West-south-west, from the South-west corner of Location 511 at Quamkadine; opposite boundaries pasallel and equal.

Northward and Westward by lines extending East-north-east 40 chains, and South-south-east 25 chains from the North-eastern corner of Special Occupation License 598; opposite boundaries parallel and equal.

AVON (Jackson's). - 100 acres.
North-north-west and West-south-west by lines extending East-north-east 25 chains, and South-south-east 40 chains from a spot on the Southern boundary of Special Occupation License 434, at the distance of 12 chains 50 links West-south-west from its Southeast corner ; opposite boundaries parallel and equal.

## AVON (Tomens').-100 acres.

IN accordance with the provisions of Number Twenty-six of the "Regulations for the Sale, Letting, Disposal, and Occupation of the Waste Lands of the Crown within the Colony of Western Australia," His Excellency The Governor in Council has been pleased to make the Rules and Directions hereunder given as following and in addition to those already publicly notified, and dated 19th August, 1873.

## By Command, <br> MALCOLM FRASER,

21. In observing for true bearing (which should always be done, in traverse work, at least every 10 miles, and in every other survey except single blocks attached to old work) first observe a meridian altitude of the sun or a star for latitude, the result should not be more than one mile from the truth; then observe the greatest elongation of any circum. polar star with the verniers clamped at $360^{\circ}$, clamp the lower plate and reverse the telescope, set the cross wires again on the star and read the verniers, the mean reading will give the correct direction of the star at its greatest elongation; then compute the angle between that line and a true South line by the formula Log. sine of polar distance minus Log. cosine of the Latitude=Log. sine of angle required; set off that angle on the vernier and the telescope will point true South. A circumpolar star is at its greatest elongation when its altitude is about $34^{\circ}$ to $36^{\circ}$ in these latitudes.
22. Plans sent to this office must be in strict accordance with the prescribed form adopted.
23. All connected surveys are to be plotted so as to show all the connections in their proper relative positions, and if such run outside the sheet line, another sheet must be added in its proper place (i.e.:-exactly over, under, or on one side, as the case may be).
24. Isolated blocks to be plotted on the diagram forms only, with connection, topography, description of country, \&c., within its boundaries. Only one block to go on one form, and on as large a scale as diagram forms allow.
25. Whenever practicable, new surveys are to be plotted on the sheets already in the office, showing all the blocks, \&c., in their proper relative positions, but the sheets that show scattered blocks are not to be used for such purpose.
26. Calculated distances not to be written on the plan but on the proper column in the tables provided for that purpose, and should always be North and South, East and West (true). If the intermediate pegs are not exactly ten chains apart the distance is to be written on the plan.
27. The measure of all angles that are not right angles are to be written on the plan.
28. Additional town surveys are to be plotted on the existing town plans if possible; if not, on a sheet on a scale of not less than four chains to one inch, showing all the details, connections with old surveys, \&c. The diagram forms are not to be used for town lots.
29. The boundaries of lands fronting on lakes or rivers are to be marked on the ground by lines, and so distinguished on the plans the same as the other boundaries.
30. The starting point referred to in the application to purchase, must always be shown on the plan.
31. A proper authority must always be obtained before marking any land in a different form from that shown in the copy of application furnished by the office.
32. No theodolite less than a five-inch to be used, except by special permission.
33. After this date, in consideration of the present advanced rate of wages now being paid throughout the Colony, the Sirveyor General may allow, in addition to the fees payable to surveyors under Number 18 of the Rules and Directions, such amounts as shall not exceed one-fifth or 20 per cent. on the whole account.
