$\operatorname{PROCLAMATION}$

By His Excellency WILLIAM Western Australia, Cleaver Francis Robinson, Esquire, Companion of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the territory of Western Australia and its Dependencies, &c., &c., &c.

(L.s.) WILLIAM C. F. ROBINSON.

HEREAS it is enacted by the second Section of the "Small Debts Ordinance, 1863," that it shall be lawful for the Governor from time to time, and at any time, by Proclamation published in *The Western* Australian Government Gazette, to constitute Local Courts for the recovery of Small Debts and Demands, to be holden at such times and places, and within such Districts throughout the said Colony as may be most fit and convenient, and as may be specified in such Proclamation; and likewise by Proclamation to alter the time, or place, or manner of holding any such Courts; And whereas it has been deemed expedient to alter, as hereinafter specified, the time for holding the Local Court at Dongarra; Now THEREFORE I, the said Governor, in exercise of such power, do hereby notify and proclaim, that the day for holding a Local Court for the recovery of Small Debts and Demands shall, after the 20th day of April instant and thenceforth, be the third Thursday in each month.

Given under my hand and the Public Seal of the said Colony, at Government House, Perth, this 6th day of April, One thousand eight hundred and seventy-seven, and in the Fortieth year of Her Majesty's Reign.

NOTICE TO MARINERS.

[No. 155.] AUSTRALIÄ, QUEENSLAND.

(1) LIGHT-VESSEL NEAR NO. VI., CLAREMONT ISLAND-INNER ROUTE TO TORRES STRAIT.

The Government of Queensland has given Notice, that a light-vessel has been moored westward of No. VI., Claremont island, in 12 fathoms water, with the beacon on the centre of Heath rocks bearing W. by N. $\frac{1}{4}$ N., distant $2\frac{1}{2}$ miles.

The vessel exhibits a fixed white light, 35 feet above the level of the sea, which should be visible in clear weather from a distance of 10 miles.

The illuminating apparatus is dioptric, or by lenses.

(2) LEADING LIGHTS ON LITTLE SEA HILL, KEPPEL BAY.

Also, that two small fixed white leading lights, which when in line lead over the position of the Timandra bank buoy, are now exhibited from Little Sea hill, Keppel bay, to assist in navigating the channel to the anchorage under Sea Hill point.

DIRECTIONS.—After passing Keppel rocks on a west course, do not bring the two lights at the Pilot station in line, before crossing the line of lights on Little Sea hill. When both these lines of lights are crossed, which should be done near the point of intersection, the Timandra bank buoy will be passed; then steer S.S.W., and if intending to anchor under Sea Hill point, alter course to S. by E. \(\frac{1}{2} \) E., when the upper light is eclipsed on a S.E. by S. bearing. Standing in, the upper light will again become visible, and when it bears N.E., anchorage will be found in about 5 fathoms at low water.

It should be borne in mind, that between Sea Hill point and Timandra bank buoy, both flood and ebb tides set strongly across the line of the leading lights on Little Sea hill.

NEW SOUTH WALES.

(3) REPORTED BANK OFF THE COAST OF NEW SOUTH WALES.

The Government of New South Wales has given Notice, that Mr. Largie, master of the barque Jerusalem, has reported the existence of an extensive bank of soundings off the coast of New South Wales, 40 miles from the land, and about the same distance south-east of the entrance to port Jackson.

Several soundings were obtained, the least water found was 20 fathoms.

At the time the soundings were obtained, a southerly gale was blowing, with very high confused sea.

(4) HARBOUR LIGHT AT ST. LEONARDS, PORT PHILLIP.
