#### Minor Roads in the Irwin District.

Colonial Secretary's Office, Perth, 20th August, 1877.

T is hereby notified, that on the recommendation of the Local Roads Board for the Irwin District, and subject to the condition that the Board provide and erect all gates or fences that may lawfully be required by the owners of fee simple lands through which such roads pass, His Excellency the Governor has been pleased to declare the following Minor Roads:—

No. 1.—A road 50 links wide extending South from the road from Yardarino to Dongarra from where it crosses the East boundary of Victoria Location 270, between Locations 270 and 281, and Tillage Leases 5083 and 6982, and Special Occupation License 825, to the Commonage.

No. 2.—A road 50 links wide between Tillage Leases 5325, 5326, 6689, 5182, and 5181, and Special Occupation License 464. The centres of the roads will be on the dividing lines between the various Locations, Tillage Leases, and Special Occupation Licenses.

#### MAHE ISLAND, SEYCHELLES.

LIGHT HOUSE.—A Light House has been erected on the N.W. edge of the southern reef at the entrance to Port Victoria from which, after 1st March, 1877, will be exhibited a fixed red light at an elevation of 37 feet above H.W., visible in clear weather at a distance of 9 nautical miles.

The light is catoptric and will shew an unbroken arc of  $142^{\circ}$  of illumination between the bearings of S. 1° E. and N. 39° W.

Vessels outside St. Anne's and the other outlying islands will have the light visible between the following bearings only, viz :

the remainder of the illuminated arc being obscured by land. A fixed red light from the same Light House will also be shewn towards the anchorage in Port Victoria (called the Inner Harbor).

LIGHT HOUSE, MAHE.—The Light House is situated in Lat.  $4^{\circ}$  36' 48" S., Long.  $55^{\circ}$  31' 0" E., is 42 feet from base to vane, built of granite on a foundation of concrete, and painted white.

white. **DIRECTIONS**,—Entering St. Anne's Road at night, give the N.W. point of St. Anne's Island a berth of three cables and steer S.W. mag: taking care to keep the Port Victoria Light (Red Fixed) between the bearings of S.W. b. W. and S.W. b. W.  $\frac{1}{2}$  W.; until the south point of St. Anne's bears E.S.E.—then steer S.W.  $\frac{1}{2}$  S. mag: and anchor with the Light bearing between W. b. S.  $\frac{3}{2}$  S. and W. b. S.

With the Light between these latter bearings the channel for entering Port Victoria (Inner Harbor) will be open, but should never be attempted by strangers at night without a pilot.

**MOORINGS.**—Moorings have been laid down for the Messageries Maritimes Steamers, at the entrance to Port Victoria, and an iron buoy painted red supports the bridles, from which the Light House bears S. 55 W. 3<sup>th</sup> cables. Ships anchoring in the vicinity of this buoy should give it a berth of half a cable to avoid fouling the moorings, the anchors for which are placed East and West nearly.

Note .- Bearings given are magnetic Var: 4° 30' W.

NORTH ISLAND.—EAST COAST. AUCKLAND HARBOUR.—Rangitoto island.a—A sunken pinnacle rock, having a depth of 4 feet and 21 feet close around, has been found near the recef which skirts the west side of Rangitoto island. A black buoy has been placed westward of the rock, and lies in 31 fathoms, with the following bearings, namely, Bean rock lighthouse (at night the green light) S.S.E.; Northern cone of Rangitoto N.E. by E. & E., and beacon on Rangitoto reef N. by W. & W. Vessels are cautioned not to pass eastward of the buoy as rocky ledges extend off the shore of Rangitoto island.b Errotum, Hydrographic Notice No. 18 of 1876:— WAMAN BOUKS—Rangeatira, shoel.c—Kahau rocks are

Breatum, Hydrographic Notice No. 18 of 1576 :=KAHAU ROCKS-Rangatira shoal.c-Kahau rocks are situated in lat. 41° 22' S. long. 175° 51' E., or about 30 miles to the north-east of cape Palliser and they are not identical with Kohau point as was assumed in that hydrographic notice. The shoal on which the stetn ship Rangatira grazed is supposed to lie E.N.E. 2 miles from Kahau rocks. The weather at the time being thick, the exact position of the danger could not be ascertained. Other dangers, the positions of which are un-known, are said to exist in the same locality.d

#### COOK STRAIT.e

**PORT N1CHOLSON.**—Baring head.*j*—Rocky ground having depths of 4½ to 7 fathoms lies N.W. ½ W. 2½ cables from Baring head. The ledge lies parallel to the coast, and is 3 cables long by one cable broad; the surf breaks on it in bad weather.

by one cable broad; the surf breaks on it in bad weather. Pencarrow point N. by W. leads westward of the reef, and of other detached rocks off Baring head. Taourakira point open of Baring head E. & S. leads southward of these dangers. **Tons rock**.—About three-quarters of a mile to the south-ward of Toms rock is a bank having a depth of 6 to 10 fathoms. From the depth of 6 fathoms Karori river bears N. & E., Karori rock is in line with cape Terawiti bearing N.W. Tide with our process of the about conception of the depth of 6 fathoms.

Tide rips may be observed on this bank, especially at flood tide.

To avoid this bank when passing the coast between cape Terawiti and Sinclair head, cape Terawiti should be well open westward of Korori rock, and Pencarrow lighthouse open southward of Sinclair head.

Luna rock, recently found by Captain Fairchild, has a depth of 6 feet, and lies about half a mile off shore with Karori rock bearing S.E. by E., nearly 9 cables distant, and Macmanaman's house E. by N.  $\frac{3}{2}$  N. The rock is steep to.

As the stream sets towards the coast between Sinclair head and cape Terawiti caution is requisite.

QUEEN CHARLOTTE SOUND.g-Cape Jackson.-Vessels should avoid the boat passage north of cape Jackson. Accord-ing to a recent examination the depths are variable; 4 fathoms was the least water found but it is stated that a vessel drawing 14 feet lately grounded in the passage.

#### MIDDLE ISLAND,-EAST COAST.

**OTAGO HARBOUR**. h—Hydra reef reported to lie about 4 miles south-eastward of Tairo head and a mile off shore, has been unsuccessfully searched for by local pilots and is not considered by them to exist. i

#### FOVEAUX STRAIT.

NEW RIVER.j-Guiding Star rock, a sunken danger having a depth of 5 feet, lies S.W.  $\frac{1}{2}$  S. 2 cables from Bombay rock and nearly in mid channel. Abreast of the danger is moored a white buoy, which by vessels entering should be left on the starboard hand. Should the buoy be adrift the rock may be avoided by not bringing Bombay rock to bear north-ward of N.E.k

#### MIDDLE ISLAND .- WEST COAST.

GREY (or Mawhera) RIVER.1—At the end of Arney Street two beacons have been creeted, which serve as leading marks for the new channel formed in the south spit.m

Strangers are warned not to take the south channel while the north channel is open, as the semaphore is not adjusted for the south channel.

#### AUCKLAND ISLANDS.n

EWING ISLAND.--A shoal extends about half a mile from the south-west part of this island. The passage between Ewing and French's island is not recommended.o

CARNLEY HARBOUR.—There is a good anchorage in 11 fathoms, inside Flagstaff point; the anchorage may be re-cognized by a sandy beach, and being close to the depôt is convenient for landing stores.

SOUTH COAST-SPENCER GULF.

#### (1) INTENDED ALTERATION IN TIPARA REEF LIGHT.

The Government of South Australia has given Notice, that on or about 1st June 1877, a light will be exhibited from an iron pile structure on Tipara reef :--

The light will be a revolving white light of the first order, showing a bright flash every thirty seconds, and elevated 100 feet above high water.

Also, that the light-vessel on Tipara reef, now showing a fixed light, will be withdrawn on the exhibition of the above revolving light.

Further particulars will be published.

#### EAST COAST-PORT JACKSON.

#### (2) STORM SIGNALS AT SOW AND PIGS LIGHT-VESSEL, AND BRADLEY HEAD.

The Government of New South Wales has given Notice, that the signal indicating an approaching southerly gale, will be shown at Sow and Pigs light-vessel, and Bradley head, in the same manner that it is at present shown from South head, port Jackson.

#### TASMANIA-BANKS STRAIT. (3) SHOAL IN MUSSEL BAY.

Information has been received from Staff-Commander Henry Stanley, R.N., in charge of Admiralty Survey, of the existence of a shoal in Mussel bay, north-east coast of Tasmania:--

This shoal (Cockle bank) has 19 feet over it at low water, and bears W.N.W. from Rocky head, distant 2 miles.

Also, with reference to Notice to Mariners. No. 90, of 19th July, 1876, on the existence of sunken rocks in Banks strait:--That Harry rock, lying N.W. by W. <sup>4</sup>/<sub>4</sub> W., nearly 3 miles from Swan island lighthouse, has 16 feet over it at low water, instead of 18 feet, as previously reported.

LEAVING PORT.

Vessels with a draught not exceeding 22 feet can now enter and leave the Port without difficulty or delay during all seasons of the year.

During the fair season, from October to 15th May, Vessels with a draught not exceeding 24 feet can enter and leave the Harbor.

Fixed Moorings are placed for Vessels of the largest class.

TIME OF TIDE FOR ENTERING PORT.

Sailing Vessels should enter Port on the ebb-tide,

Steamers can enter either flood or ebb at the Pilot's discretion.

Masters of Ships should not on any account attempt to enter the Harbor without a Pilot.

HARBOR IMPROVEMENTS.

AMADOK IMPROVEMENTS. Among the extensive works executed, a Breakwater has been built, running out from Manora Point in a S. by E. direction, to a distance of 1,500 feet into 5 fathoms of water, this affords complete shelter to the entrance channel during the South-West Monsoon; also a channel has been opened through the Bar with a depth of 20 feet at low water spring-tides, 500 feet in breadth; the entrance is marked by buoys, one on each side of the channel.

NOTE.-A Mail Steamer arriving off the Port at night should burn two blue-lights in quick succession; during the fair season a Pilot will at once board, but during the Monsoon she must keep off the Port until daylight.

A Red Light is exhibited at the extreme end of the Breakwater during the fair season only.

#### APPROACHING THE PORT. COAST OF SIND. INDUS BANKS.

The coast of Sind should be approached with great caution, too much attention cannot be paid to the lead, more especially in passing the banks of the Indus, which are extending con-siderably to seaward.

By recent Survey, the edge of the shoal water is  $3\frac{1}{3}$  miles to seaward of its former position.

It is now in

Latitude ... 24° 4′ 24″ N. Longitude ... 67° 12′ 48″ E. (Kurrachee being in 66° 58′ 15″ E.)

By night, a Vessel should give the banks a berth of 15 to 20 miles, and if after passing the "Swatch," she does not get less

than 18 to 20 fathoms, she may haul to the Northward, not coming into less than 15 fathoms until the Kurrachee Light is seen.

By day, the breakers on the edge of the banks are a good guide, unless the water is quite smooth; but it is hardly possible for a Vessel to run ashore by day on account of the marked discoloration of the water, which extends some distance outside the banks.

The tides during the springs are strong, the flood sets to the S.E., and the ebb to the N.W.

From February to end of Monsoon a strong South-Easterly current may be expected, running at a rate of from 15 to 45 miles a day.

During the South-West Monsoon, Vessels should make Ras Mauri (Cape Monge), which is 18 miles W:  $\frac{1}{2}$  N. from Manora Light-House, and keep to windward of the Port if the weather is thick, or if the tide does not suit for entering the Harbor. Allowance must also be made for a strong set to the South-East, which prevails more or less during the South-West Monsoon.

Do not bring Manora Point to the Eastward of E. by N., or go under 15 fathoms near Cape Monze.

Masters of Ships should endeavor to make the Port at day-light, and can with safety approach into 8 fathoms to about 2 miles distance from the Light-House, keeping it on any bearing from N.E. to N.N.E., and heave to for a Pilot.

ANCHORAGE IN THE ROADS.

From June to the middle of September, Ships should not on any account anchor, but stand off and on, keeping the Light-House bearing from N.N.E. to N.E.,--I to 2 miles distance---until boarded by a Pilot, or directed by signal.

September to end of March.

Anchorage-Light-House N. by E. to N.N.E., distance 1 mile, 7 fathoms.

April and May.

Anchorage-Light-House N.N.E. to N.E., distance  $1\frac{1}{2}$  a mile, 8 fathoms.

NOTE.—Since 1831, the Ships "Admiral Boxer" and "John Starr" have been totally lost on or near the banks of the Indus, and the Ships "Thomas Campbel," "Augusta," "Diadem," and the Steamer "Pioneer" have grounded on them, but eventually floated off.

Two large Troop Ships have also in the same period touched on them. All these casualties were principally owing to not making allowance for a strong set to S.E., and not using the lead.
