THE following general By-Laws and Regulations, framed in accordance with the provisions of "The Elementary Education Act, 1871," as amended by the 41st Victoria, No. 11, have been this day passed by the Central

Board of Education, and are submitted for the approval of His Excellency the Lieutenant-Governor.

The By-Laws previously passed are hereby repealed.

I.—SCHOOLS.

1. The Central Board of Education will establish, maintain, or assist four classes of Schools, viz. :—

1. Elementary Government Schools.
2. Elementary Assisted Schools.
3. Provisional Schools.
4. Half-Time Schools under Itinerant Teachers.

GOVERNMENT SCHOOLS.

Building Grant.

2. In the case of purely Government Schools the Central Board will distribute the grant entrusted to them in such proportion as they may deem expedient towards the erection, extension, or repair of School Buildings; but when the inhabitants of any locality are prepared to contribute a portion not less than one-third of the cost, such locality shall have a preferential claim on the Building Grant at the disposal of the Central Board.

3. The site must be duly vested in the Crown or Central Board, before any grant towards the building can be made.

4. In every deed by which the site is vested in the Crown or Central Board there shall be inserted a clause declaring that the land and buildings thereon to which it refers shall be for ever exclusively appropriated for the purposes of the Government School of the locality where it is situated, and such school shall be for ever open to the children of all religious denominations without distinction, and subject to the control of the Central Board of Education or such other authority as may hereafter legally assume the functions thereof. Provided nevertheless, that should the Central Board consider it desirable to erect a new school house on some other site, it shall be lawful for that Body with the consent of the Crown, to dispose of any site or building which may have been vested in the Crown or Central Board for school purposes so long as the proceeds thereof be appropriated for the purchase of another site and the erection of a new building for such school.

5. Before making any grant for building purposes the Central Board must be satisfied that the work will be carried on under trustworthy supervision. Before payment of the last instalment, the Central Board must be satisfied that no debt remains on the building, which this payment will not liquidate; and that it is in all respects fit and ready to be opened for school purposes.

6. Plans for the erection of Government Schools will be supplied by the Central Board; but plans locally provided may be adopted, if approved by the Central Board.

7. Applications for the establishment or erection of Government Schools are to be made on Forms provided for that purpose. (Appendix A).

Establishment.

8. Government Schools may be established in any locality in which the Central Board is satisfied that an average daily attendance of twelve scholars, between the ages of four years and sixteen, can be maintained.

9. Should the average daily attendance at any Government School (Provisional and Half-time Schools excepted,) during a period of six months fall below twelve, such school shall cease to be maintained as a Government School, unless it can be shewn that temporary causes have prevented the attendance from reaching the required standard.

Staff.

10. The Staff of Teachers to be employed in Government Schools shall, at the discretion of the Central Board and so far as practicable, be regulated according to the following scale, viz. :—

11. In such of the larger schools as afford special facilities for the training of Pupil Teachers for the future service of the Board, two Pupil Teachers may be appointed in lieu of one Junior Assistant.

ASSISTED SCHOOLS.

Certificate of Recognition.

12. Before any school can be certified as an Assisted School under the Elementary Education Act, 1871, and amendments thereto, the Central Board must be satisfied:

1. That the school is conducted as an Elementary school according to the provisions of the said Act and amendments.
2. That the school premises are healthy, well lighted, drained, and ventilated; that there are suitable offices; that the school is properly furnished with school appliances; and that the rooms contain not less than one hundred cubical feet of space, nor less than ten square feet of area for each scholar in average attendance:
3. That three persons being the managers or promoters of such school, have designated one of their number to sign the receipts for Grants on behalf of the school, and to conduct all correspondence relative to school matters.

13. Certificates entitling Assisted Schools to claim aid from the Educational Grant may be withdrawn, should:

1. The average attendance for a period of six months fall below the required Standard:
2. The managers or promoters, after six months' notice, fail to remedy any defect in the premises which seriously interferes with the efficiency of the school, or to provide proper furniture, books, maps, and other requisites of elementary instruction.
3. Any of the By-Laws or Regulations of the Central Board be infringed.

STAFF.

14. The number of teachers to be employed in Assisted Schools shall, at the discretion of the Central Board, be regulated by the average attendance, in accordance with the scale under By-Law 10, which provides for the teaching staff in Government Schools.

15. The Central Board may at any time require to be satisfied that the teachers comprising such staff are competent to perform their respective duties.

GRANT-IN-AID.

16. The Grant-in-aid to Assisted Schools will consist of:

1. A fixed annual sum, calculated on the average daily attendance for the year ended 31st December preceding:
2. An allowance for successful teaching, to be determined by the results of the Inspector's half-yearly examination of scholars under the prescribed Standards.

17. The Fixed Annual sum payable to an Assisted School shall be one-half the total amount of yearly salaries paid to the teaching

staff of a Government School in respect of the same average attendance; viz., at the rates shewn in table below:—

18. An allowance on examination to any Assisted School will be paid on behalf of any scholar present at the half-yearly examination, who shall have attended such school not less than sixty half days in the half year.

1. Between the age of four and seven years, the sum of One shilling and sixpence.
2. Between seven and sixteen, the sum of Six shillings and sixpence, to be paid *pro rata* subject to passing the prescribed standards of examination; viz., Reading, One shilling and sixpence; Writing, One shilling and sixpence; Arithmetic, One shilling and sixpence; Grammar, One shilling; and Geography, One shilling.

19. All Grants to Assisted Schools shall be paid to the authorized Managers of such Schools, who will make their own arrangements in respect of the teachers' remuneration.

20. Should the Managers of any Assisted School fail to employ the full teaching staff as required under By-Law 14, or manifest unnecessary delay in filling up any vacancy in the staff, the grant-in-aid to such school may be reduced by the amount which would have been payable in respect of such teacher, according to the scale under By-Law 17.

21. A Certified Return of the teaching staff employed in every Assisted School must be transmitted, quarterly, by the Managers to the Central Board of Education, on proper Forms (Appendix B).

22. Applications for grants-in-aid to Assisted Schools must be made on proper Forms (Appendix C).

PROVISIONAL SCHOOLS.

23. Pending the establishment of Government Schools, and with the view of ascertaining whether the average attendance required for a Government School can be maintained

in any locality, the Central Board may recognise and assist as Provisional Schools such as have been established by private persons and are not denominational or sectarian.

24. The grant-in-aid to Provisional Schools shall not extend beyond the period of twelve months, nor exceed in amount the sum of Three pounds ten shillings per head on the average daily attendance.

25. While in receipt of aid, Provisional Schools shall be conducted in accordance with the Regulations of the Central Board.

26. In applying for aid to Provisional Schools, the promoters must satisfy the Central Board that the teachers are competent to perform their duties, and are persons of good moral character.

HALF-TIME SCHOOLS UNDER ITINERANT TEACHERS.

27. Half-time Schools under itinerant teachers may be established wherever a number of children of school age are residing within an estimated radius of ten miles from a central point, and can be collected in groups of not less than eight children in each.

28. Such school may be open for a portion of each day, or for a certain number of days in each week, or for alternate weeks, as may be directed by the Central Board.

29. The remuneration of itinerant teachers will be specially fixed by the Central Board.

30. Applications for the establishment of Half-time Schools must state the number of children who will attend at each place to be visited by the teacher; and must also satisfy the Central Board that proper accommodation for the teacher and scholars can be procured.

31. The Central Board reserves to itself the right to judge of the expediency of establishing, maintaining, or assisting Elementary Schools, subject to the provisions of the Elementary Education Act, and all grants must depend on the funds placed at the disposal of the Board.

II.—TEACHERS.

Appointment.

32. The appointment of Teachers to Government Schools rests with the District Boards, subject to the approval of the Central Board of Education.

33. Applications for employment as Teachers of Government Schools must be supported by satisfactory Testimonials from persons competent to form an opinion as to the character and general fitness of the applicants, who may also be required by the Central Board to pass an examination in the Elementary branches of Instruction, before appointment to the charge of a Government School.

34. Recommendations of Teachers for the approval of the Central Board must in every case state

1. The age of the applicant.
2. His or her experience, if any, in School management.

35. No person will be employed as Principal Teacher or recognised as a Principal or Senior Assistant Teacher in any Elementary School who has not arrived at the age of 18 in the case of a female, or 20, if a male.

Classification.

36. Teachers' Certificates of qualification will be divided into two classes, viz. :—

1. Certificate of Efficiency. (Appendix L).
2. Certificate of Competency. (Do. L).

The programme of examination will be found in Appendix K.

37. Examinations will be held periodically at Perth and at such other places as the Central Board of Education may from time to time appoint; due notice of which will be given. Candidates desirous of presenting themselves at these Examinations must notify their intention to the Central Board.

38. Candidates for the office of Senior Assistants, or as Principal Teachers of Schools in which Pupil Teachers are employed, must possess a Certificate of Efficiency. (Appendix L.)

39. Junior Assistants, and Teachers of Schools where the attendance warrants the employment of Stipendiary Monitors, must have obtained a Certificate of Competency. (Appendix L.)

Remuneration of Teachers.

40. The remuneration of Principal Teachers will consist of:

1. An annual salary calculated on the average attendance of his or her school for the year ended the 31st December, preceding.
2. The bonus for results of successful teaching, subject to the provisions of By-Law 43.

41. The Annual Salary to be paid to the Principal Teacher of any Government School shall be fixed during the month of January of that year, and shall be computed on the average attendance of the preceding year, according to the following scale :—

42. The bonus for successful teaching will be determined by the results of the Inspector's Half-Yearly Examination of scholars under the prescribed standard, and will be calculated as follows, viz. :—

For every child present at the examination who has attended not less than sixty half-days in the half-year there will be paid

1. Between the ages of four and seven the sum of three shillings.
2. Between the ages of seven and sixteen the sum of thirteen

shillings, to be paid *pro rata*, subject to passing the prescribed Standards of examination, viz. :—Reading, three shillings; Writing, three shillings; Arithmetic, three shillings; Grammar, two shillings; and Geography, two shillings.

43. Assistant Teachers will be paid as follows :—

44. Teachers on their appointment to Established Schools will receive the same rate of annual salary as paid to the late Teacher.

45. Teachers are prohibited from undertaking other duties which may interfere with the due performance of their five hours' School Instruction.

46. The duties of Teachers are :—

1. To observe faithfully the regulations of the Central Board :
2. To carry out the suggestions of the Inspector of Schools, to the best of their abilities :
3. To teach according to the course of secular instruction (Appendix D) :
4. To keep the School Records, and to furnish quarterly, to their District Boards, accurate returns :
5. To see that the undermentioned documents are constantly exhibited in a conspicuous place in the school room :
 - a. The Conscience Clause (Education Act, Clause 22).
 - b. Time Table.
 - c. Scale of School Fees.
 - d. List of School Books supplied by the Central Board, with sale prices (Appendix F).

PUPIL TEACHERS.*Appointment.*

47. Pupil Teachers will be employed in such of the larger schools as may appear to the Central Board to offer special advantages for training to the profession of teaching.

48. Candidates for the office of Pupil Teacher must be at least fifteen years of age, if a boy, and fourteen years of age if a girl, of good character, and free from any bodily infirmity likely to impair their usefulness. They must also be able to pass an examination by the Inspector, as provided in Appendix H.

49. The District Board must furnish satisfactory certificates that the moral character of the candidates is good.

50. A Pupil Teacher's term of service shall be four years, to be secured by indenture of apprenticeship.

Remuneration.

51. Pupil Teachers will receive an annually increasing stipend, subject to obtaining certifi-

cates of satisfactory conduct, and passing a yearly examination according to a defined syllabus. (Appendix H.)

52. The remuneration of Pupil Teachers will consist of:—

1. Five hours' instruction per week from the Teacher.
2. An annual salary as follows:—

Training.

53. The Principal Teacher of a School in which Pupil Teachers are employed will be required to devote not less than five hours per week, before or after School hours, to their instruction; but not more than two hours out of the five shall be on the same day.

54. The hours at which the Pupil Teachers are instructed must be shown on a Time Table to be suspended on the walls of the School-room.

55. The Teacher shall receive for instructing each Pupil Teacher the sum of Five pounds annually, contingent on the latter passing the yearly examination; or, at the discretion of the Board, in the event of his or her resigning, a proportionate sum for any lesser period during which such Pupil Teacher may have received instruction.

56. Pupil Teachers who satisfactorily complete their apprenticeship shall be entitled to receive a Certificate of Competency; and may, after two years' probationary service in an Elementary School, if they exhibit sufficient skill in school management and pass the Examination as laid down in Appendix K, be awarded a Certificate of Efficiency.

Monitors.

57. Stipendiary Monitors must be at least fourteen years of age, if a male, and thirteen if a female, and have passed the Fifth Standard (Appendix D), or be able to pass an equivalent examination by the Inspector of Schools.

58. The Annual Stipend of Monitors will be:—

III.—COURSE OF INSTRUCTION.

59. The ordinary course of secular instruction, the arrangement and work of the classes, and the promotion of the scholars, will be regulated by programme of Standards (Appendix D), except otherwise sanctioned by the Central Board.

60. The following Daily Routine and Time Table shall be observed in all Government and Assisted Schools, unless altered by the special sanction of the Central Board:—

- 9 h. to 9½h.—Pupils assemble for lessons.
- 9½h. to 9¾h.—Read Bible and Religious Books sanctioned by the Central Board.
- 9¾h. to 11¾h.—Secular Instruction.
- 11¾h. to 12¾h.—Recess.
- 12¾h. to 3h.—Secular Instruction.

61. In all Elementary Schools the Attendance Register must be called and marked both morning and afternoon, immediately at the commencement of the two hours' continuous Secular Instruction.

62. A detailed Time Table, clearly exhibiting the hours set apart for Bible Reading or Special Religious Teaching, and the subject and duration of lessons given during the time allotted to Secular Instruction, must be suspended in a conspicuous place in every Elementary School. (Appendix E).

63. The undermentioned Registers and Forms are to be kept by the teacher in every Elementary School, according to the directions supplied with each:—

1. Admission Register:
2. Register of Attendance, Absence, and Payments:
3. Summary of Class Registers:
4. Time Table:
5. Standards of Examination:
6. A list of Books used during Secular Instruction, and such religious books as may be sanctioned for use by the Central Board.

64. The vacations sanctioned by the Central Board of Education are:—a fortnight at Christmas, a week at Easter, a week at Midwinter, and a week at Michaelmas.

65. The specified Holidays are Christmas Day, Good Friday, the Anniversary of the foundation of the Colony, the Queen's Birthday, Queen's Coronation day, the Prince of Wales' Birthday; and such other holidays as are allowed to be kept in the Public Offices.

66. Government Schools are never to be closed on the ordinary school days without the written consent of the District Boards; and if closed more than three days, the circumstance must be reported to the Central Board.

IV.—ATTENDANCE.

67. The average attendance shall be ascertained by dividing the total number of morning and afternoon attendances by the total number of half-days the school has been open during the period for which the computation is made. But in order that the salaries of teachers may suffer no reduction through non-attendance of Pupils owing to epidemics, or any unusual occurrence, the Central Board may allow the mornings and afternoons in which the attendance was fifty per cent. lower than the ordinary attendance, to be thrown out in computing the daily average for the time that any school was so affected.

68. No Scholar between the age of four and seven shall be allowed to attend a separate Government Boys' or Girls' Department where a Government Infants' or a Government Mixed (Girls' and Infants') School is maintained.

69. Statistical Returns of Attendance, &c., must be furnished quarterly and annually, or at such other times as the Central Board or the Inspector may require.

70. Remuneration will be withheld from Schools should it be found that the School Registers or Returns have been wilfully falsified, or so inaccurately kept as not to be accepted as trustworthy.

71. Teachers in Government Schools found guilty of wilful falsification of Returns, will be instantly dismissed.

72. In Assisted Schools, which are also certified under the Industrial Schools Act, 1874, the employment of scholars in industrial training during ordinary school hours, for not more than five hours per week, may be reckoned as school attendance, provided that such partial exemption from school instruction shall not be claimed for any scholar who has not passed the Third Standard.

V.—SCHOOL FEES.

73. The rate of School Fees payable *in advance* for children attending purely Government Schools shall be regulated according to the following scale:—

A reduction of one-third will be made when more than two of one family attend. Special recommendations from District Boards for reduction of fees will be considered by the Central Board.

74. Free Scholars will be admitted into the Government Schools, upon the recommendation of District Boards, if approved by the Central Board.

75. The Central Board of Education desires to impress upon the District Boards the necessity of due caution being exercised in recommending Free Certificates, as the privilege should only be extended to those who are actually unable to pay the School Fees, and likewise the necessity of enforcing punctual and regular attendance, as the first condition upon which the Certificates will be granted.

76. The written orders from District Boards entitling scholars to gratuitous instruction must be kept by the Teachers, as their authority for entering such scholars on the Free List, in the Monthly or Quarterly Fee Returns.

77. In all Schools, except Assisted Schools, Teachers must collect the authorised Fees from the scholars and transmit the amount monthly or quarterly to the Secretary to the Central Board, as may be directed.

VI.—DISTRICT BOARDS.

78. The District School Boards shall take all necessary measures to carry out the provisions of the 16th, 28th, and 30th Sections of the Elementary Education Act; and shall also exercise the following functions:

1. To take care that the school buildings are not used for unsuitable purposes:
2. To report to the Central Board any want of repair in the school buildings (with probable cost of same), or insufficiency of accommodation, suitable furniture, or school apparatus:

3. To take precautions for excluding from the School, during the ordinary business, all books not sanctioned by the Central Board:
4. To inspect, periodically, the School Registers and Records, and to countersign the Returns made to the Central Board:
5. To inquire into and forward to the Central Board all applications for gratuitous instruction which they can recommend:
6. To observe whether the teachers punctually and regularly discharge their duties; to report their conduct to the Central Board when in fault; and to protect them from all frivolous and vexatious complaints:
7. To suspend a Teacher from Office pending the decision of the Central Board, should there be *primâ facie* evidence of gross irregularity or immoral conduct:
8. To afford every facility to the Inspector in the discharge of his duties:
9. To be the medium of communication with the Central Board on behalf of the Elementary Schools of the District:
10. To appoint a Secretary, who shall conduct all correspondence with the Central Board of Education in the name and on behalf of the District School Board.

VII.—INSPECTOR OF SCHOOLS.

79. The Inspector will be under the control and direction of the Central Board, and his duties shall be as follows:

1. He will be required to visit and examine, for results, every Elementary School, at least once in six months:
2. He will also be expected, as often as practicable, to make incidental visits; and special visits under instruction from the Central Board; and to transmit to the Central Board at the end of each quarter a diary of all visits made, and examinations held by him during the quarter:
3. At all visits to schools he will ascertain whether the general Rules and Regulations of the Central and District Boards are complied with. He will review the Returns, and compare them with the School Registers:
4. He will point out privately to the Teacher any instance of neglect or violation of Rules of the Central Board which he may have observed; and will suggest such improvements in the mode of teaching or general management of the school as may seem desirable:
5. The Inspector will not give any notice of visit (except at each Half-yearly Examination), but previous to leaving the District he will communicate with the Chairman of the District Board:
6. He will report the result of each Half-yearly Examination to the Central Board within fourteen days from the

date of the Examination; and will also transmit a copy of such report for the information of the District School Board:

7. The Inspector will act generally as the agent of the Central Board, and procure such information on all matters connected with the Elementary Schools as the Central Board may from time to time require:
8. At the end of the year he will draw up a report on the general condition of the Elementary Schools in the Colony, and transmit the same to the Central Board by the 15th February.

Canning Roads Board.
