The Bankruptcy Act, 1871.

IN THE SUPREME COURT.

In the matter of a Bankruptcy Petition against Louis Albert Pontt, of Mount Hill, in the Victoria District, in the Colony of Western Australia, Station Manager, and Storekeeper, Dealer, and Chapman.

U PON the hearing of this Petition this day, and upon proof satisfactory to the Court of the debt of the Petitioner, and of the trading, and of the act or acts of Bankruptcy alleged to have been committed by the said Louis Albert Pontt having been given, and upon reading his written consent to the Petition being heard and adjudicated upon forthwith (as filed in this Court), it is ordered that the said Louis Albert Pontt be and he is hereby adjudged Bankrupt.
