IN THE SUPREME COURT OF WESTERN AUSTRALIA.

In the matter of Edward Seckington, of Bunbury and Kojonup, a Bankrupt.

HOMAS WILLIAM SPENCER, of Bunbury, in the Colony of Western Australia, Merchant and Storekeeper, has been appointed Trustee of the property of the bankrupt. The Court has appointed the public examination of the bankrupt to take place at the Supreme Court House, in Perth, on the ninth day of June next, at Eleven o'clock in the forenoon.

All parties having in their possession any of the effects of the bankrupt must deliver them to the Trustee, and all debts due to the bankrupt must be paid to the Trustee.
