AUSTRALIA—TORRES STRAIT. NORMANBY SOUND.

SUNKEN DANGER OFF HEATH POINT.

The Queensland Government has given Notice that the Harbour Master at Thursday island has reported the existence of a sunken danger lying in the fairway of the channel between Prince of Wales and Thursday islands, Normanby sound:—

This danger (Pinnacle rock) is stated to be 150 feet long and 50 feet broad, with not more than 13 feet at low water on its shoalest part, which appeared to be a pinnacle rock, with foul ground around, and a strong tide rip over it; it lies with the following bearings, viz.:—

Heath point rock ... Webb point

(The bearings are Magnetic. Variation $4\frac{89}{4}$ Easterly in 1880.)

4. The structure is a square two-storey building, with an octagonal tower in the centre, on which the lantern is placed; the tower and balcony of the upper storey are painted red, the rest of the building is white.

5. The fixed light at present exhibited from the tower on St. Pant's Hill, Malacca, will still be continued as a Harbour Light until further notice.
