HEREAS by the third section of "The Stamp Act, 1881" (the 44th Vict., No. 20), it is amongst other things enacted that the said Act shall commence on such day after the 30th day of September next as the Governor may by Proclamation, to be inserted one calendar month beforehand, appoint: Now THEREFORE I, the said Governor, by virtue and in exercise of the powers and discretions vested in me, as aforesaid, do by this my Proclamation appoint the 1st day of November next ensuing as the day on which "The Stamp Act, 1881," shall commence; and the same shall commence and take effect on and after that day accordingly.
